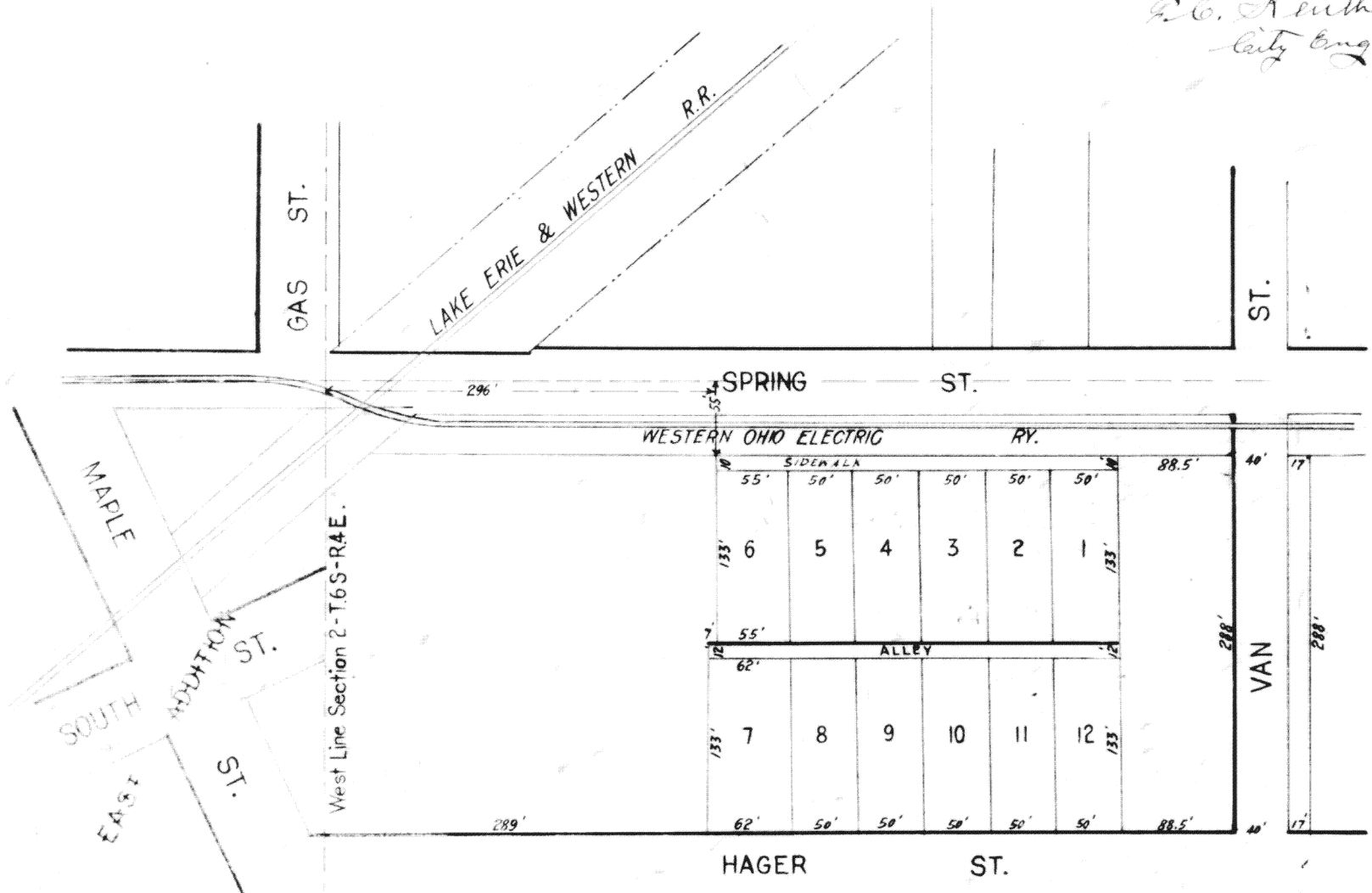

Resolution to approve the plat of the Scott
 Wilkins subdivision of a part of Out Lot No. 118 to the City of St.
 Marys, Auglaize Co., Ohio. Resolved by the Council of the City of St. Marys
 Auglaize Co., Ohio, this follows: Section I. That the Plat of the Scott Wilkins sub-
 division to the City of St. Marys, Ohio, the same being located in the west middle part of the
 north part of Out Lot No. 118 to the said City as prepared and plated by the City Engineer
 of said City be and the same is hereby approved and accepted.

Section II. That this Resolution shall take Effect and be in force from and after
 its passage and publication according to Law. Done at the Council Chamber
 in the City of St. Marys, Auglaize Co., Ohio, this 5th day of March A.D. 1913

I now all Men:-
That whereas the undersigned are the owners of the tracts of land herein subdivided, the same being located in the west part and the Middle part of the West Middle part of the North part of Out Lot 118 to the City of St. Marys, Suglaize County, Ohio, the said parties having acquired the same by separate deeds, describing distinct and separate portions of said subdivisions And whereas the said owner of said tracts of land having joined herein for convenience in platting said tracts, do hereby each certify, promise and agree, that the undersigned own the several lots of said subdivision as his or her individual and separate property and as shown on the accompanying Plat as follows that is to say:-

Scott Wilkins - Lot numbers 1, 2, 3, 4, 5, 6, 7, 10, 11 and 12 as shown on the accompanying plat:

Tena Claus - Lot numbers 6 and 7 as shown on the accompanying plat, and we do hereby set apart, dedicate and convey the sidewalks and Alley as indicated on the accompanying plat to the public use of the inhabitants of St. Marys, Ohio, and to the general public forever for sidewalk and alley purposes; should however the said sidewalk as indicated on the plat for any reason, be abandoned by the said City of St. Marys, Ohio, and cease to be used for sidewalk purposes, then the ownership right and title of said sidewalk shall be vested in the owner of the lot or fraction of lots and lands abounding and abutting upon the south side of said sidewalk at the time of said abandonment, and in that event the sidewalk so abandoned shall become a part and parcel of the lot or fraction of a lot abounding and abutting it upon the South and each lot or fraction of a lot shall have added to its area so much of said sidewalk, so abandoned, as lies immediately North of said is contiguous to it and we do hereby acknowledge the accompanying plat to be a true and correct plat of the lots and lands owned by us situated in the North part of Out Lot 118 to the City of St. Marys, Ohio.
