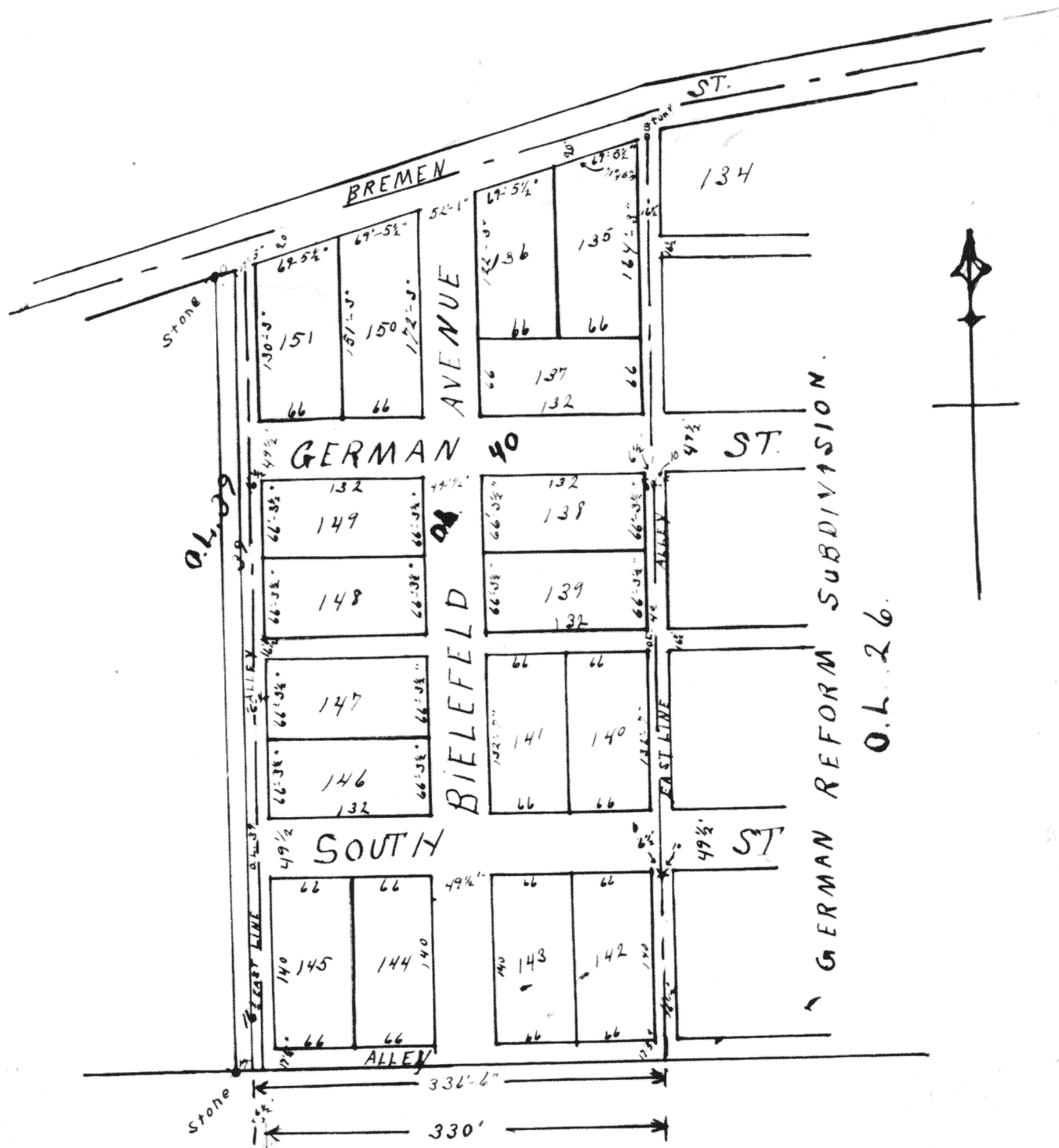


BIELEFELD'S SUBDIVISION OF

Be it Ordained by the Council of the Village of New Knoxville State of Ohio:

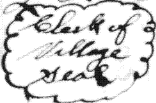
Section I, That the plat of the Bielefeld's sub-Division of out Lot Forty (40) and the East part of out Lot Thirty-nine (39) in the Incorporated Village of New Knoxville, Suglaine County, State of Ohio, as prepared and platted by the owner of said real estate, Henry W. Bielefeld and O.C. Kuntz, the said O.C. Kuntz being the engineer, and the same is hereby approved, adopted and accepted, including the dedication of streets and alleys therein designated.

Section II That this ordinance shall take effect and be in force from and after the earliest period allowed by law, and after the proper transfer and record of said plat in the records of the Recorder of Suglaine County, Ohio,
