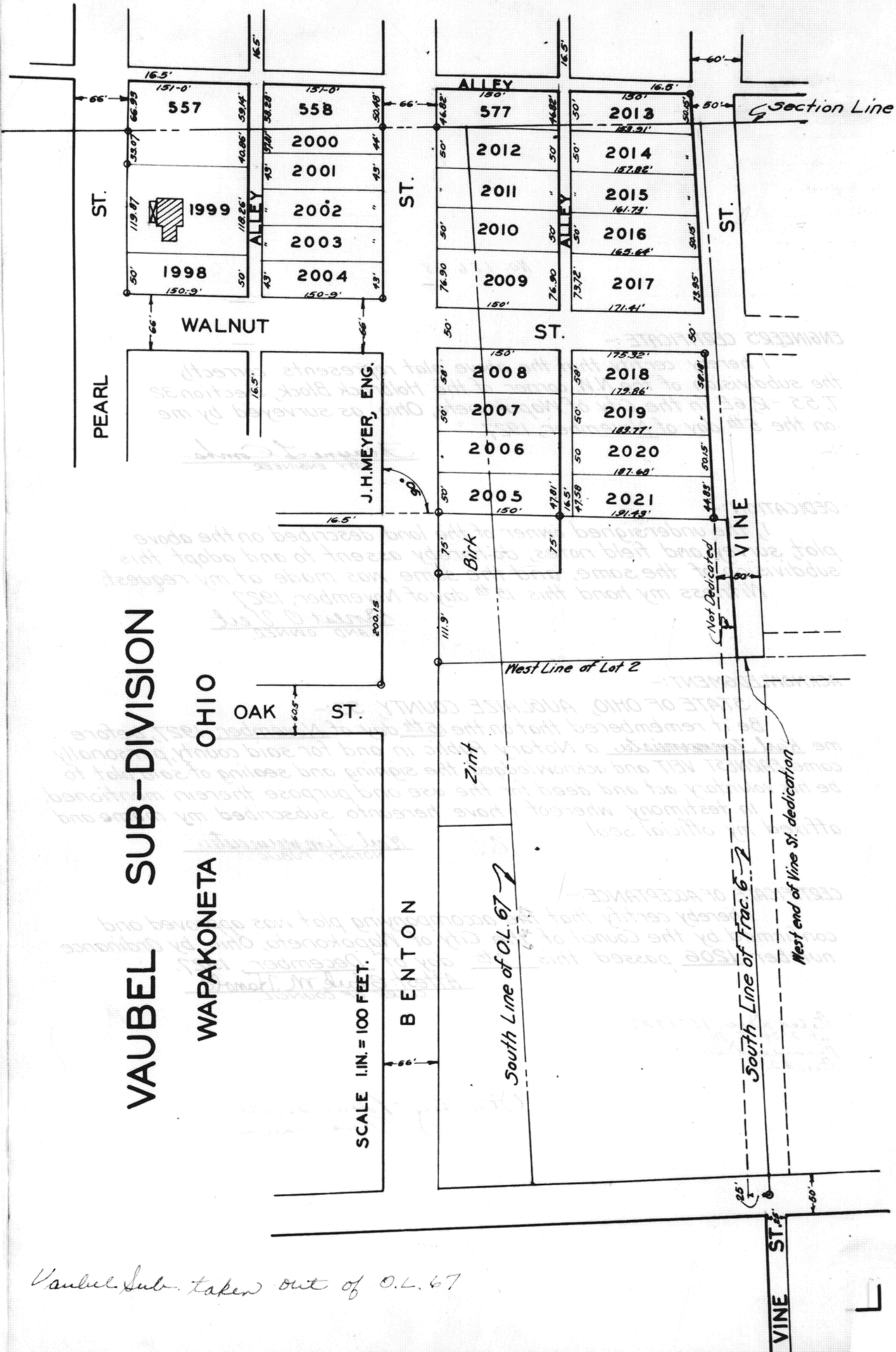


VAUBEL SUB-DIVISION
