MR. KORSPETER PRESENTED AND MOVED THE ADOPTION OF THE FOLLOWING

RESOLUTION

WHEREAS, A PETITION FOR ANNEXATION OF TERRITORY ADJACENT TO THE CITY OF WAPAKONETA, HUGLAIZE COUNTY, OHIO HAVING BEEN FILED ON AUGUST 4TH, 1942 WITH THE BOARD OF COUNTY COMMISSIONERS, AND THIS BEING THE DATE SET FOR HEARING ON SAID PETITION, AND

WHEREAS, SAID PETITIONERS HAVE AUTHORIZED HOMER HOUSE TO ACT AS THEIR AGENT IN SECURING THE ANNEXATION OF SAID TERRITORY KNOWN AS RAUTHLAND ADDITION, LYING IMMEDIATELY EAST OF THE CORPORATION OF WAPAKONETA, OHIO. THEREFORE BE IT

RESOLVED, BY THE BOARD OF COMMISSIONERS OF HUGLAIZE COUNTY, OHIO THAT THE PRAYER OF THE PETITION BE GRANTED AND THAT THE TERRITORY LYING IMMEDIATELY EAST OF THE CORPORATION OF WAPAKONETA, OHIO, KNOWN AS RAUTHLAND ADDITION BE ANNEXED TO THE CITY OF WAPAKONETA, OHIO, DESCRIBED AS FOLLOWS:

"BEGINNING AT THE MIDDLE OF THE INTER-SECTION OF RAUTHLAND AVENUE AND PIKE STREET; THENCE EAST TO LOT #1157 IN SAID RAUTHLAND ADDITION; THENCE SOUTH TO THE CENTER OF THE INTERSECTION OF THE ALLEY RUNNING NORTH AND SOUTH AND BELLEFONTAINE STREET; THENCE IN A NORTHWESTERLY DIRECTION TO THE INTERSECTION OF BELLEFONTAINE STREET AND RAUTHLAND AVENUE; THENCE NORTH TO THE PLACE OF BEGINNING."

AND BE IT FURTHER

RESOLVED, BY THE BOARD OF COMMISSIONERS OF HUGLAIZE COUNTY, THAT THE PETITION BE PRESENTED TO THE COUNCIL OF THE CITY OF WAPAKONETA, OHIO, FOR FURTHER LEGISLATION.

ORDINANCE NO. 1502

ACCEPTING THE APPLICATION FOR ANNEXATION OF TERRITORY BE IT ORDIAINED BY THE COUNCIL OF THE CITY OF
WAPAKONETA, STATE OF OHIO:

SECTION 1. THAT THE APPLICATION OF HOMER C. HOUSE AND OTHERS FOR THE ANNEXING OF THE FOLLOWING DESCRIBED
TERRITORY IN THE COUNTY OF HUGLAIZE AND ADJACENT TO THE CITY OF WAPAKONETA.

BEGINNING AT THE MIDDLE OF THE INTERSECTION OF RAUTHLAND AVENUE AND PIKE STREET; THENCE EAST TO
LOT #1157 IN SAID RAUTHLAND ADDITION; THENCE SOUTH TO THE CENTER OF THE INTERSECTION OF THE ALLEY RUNNING
NORTH AND SOUTH AND BELLEFONTAINE STREET; THENCE IN A NORTHWESTERLY DIRECTION TO THE INTERSECTION OF BELLE-
FONTAINE STREET AND RAUTHLAND AVENUE; THENCE NORTH TO THE PLACE OF BEGINNING.

AN ACCURATE MAP OF WHICH TERRITORY, TOGETHER WITH THE PETITION FOR ITS ANNEXATION, AND OTHER PAPERS RELATING THERETO, AND A
CERTIFIED TRANSCRIPT OF THE PROCEEDINGS OF THE COUNTY COMMISSIONERS IN RELATION THERETO ARE ON FILE WITH THE CLERK
OF THE COUNCIL OF SAID CITY, AND THE SAME IS HEREBY ACCEPTED.

Mr. Korspeter presented and moved the adoption of the following Resolution.

Whereas, a Resolution was passed by this Commission on the 8th day of September, 1942, authorizing the annexation by the City of Wapakoneta, Ohio, of certain territory, adjacent to said city, known as Rauthland Addition to said city and as described in the aforesaid Resolution; and

Whereas, the description of said territory does not conform to the plat and the petition submitted with the Resolution and Petition;

Now therefore be it resolved, that said description be amended to read as follows:

Beginning at the intersection of North right-of-way line of Middle Street and the East Corporation line of Wapakoneta, (which) is also the West right-of-line of Rauthland Avenue extended North; thence East on the North right-of-way line of said Middle Street to the East right-of-way line of the platted alley in Rauthland Addition located on the East side of said addition; thence South on the East line of said alley to its intersection with the South right-of-way line of Bellefontaine Street; thence in a Northwesterly direction along the South right-of-way line of Bellefontaine Street to its intersection with South right-of-way line of Fredericks Street extended East; thence West on the South right-of-way line of Fredericks Street to its intersection with the East right-of-way line of Rauthland Avenue located in the Second Rauthland Addition; thence North on the East right-of-way line of said Rauthland Avenue to an iron pin at its intersection with the South line of Bellefontaine Street; thence in a Northwesterly direction along the South line of Bellefontaine Street to its intersection with the West right-of-way line of Rauthland Avenue Addition extended South; thence North along the West right-of-way line of Rauthland Avenue to its intersection with the North right-of-way line of Middle Street at the place of beginning.

Ordinance No. 1572

To amend the Description of territory known as Rauthland Addition to the City
of Wapakoneta, Ohio

Whereas, Ordinance No. 1505 was passed by this Council on the 2nd day of December, 1942, authorizing the annexation to the City of Wapakoneta, Ohio, of certain territory, adjacent to said city, known as Rauthland Addition to said city, and as described in said Ordinance No. 1505; and

Whereas, the description of said territory does not conform to the plat and the petition submitted with said Ordinance No. 1505 and as contained in said Ordinance No. 1505;

Now therefore be it ordained, that said description be amended to read as follows:

Beginning at the intersection of the North right-of-way line of Middle Street and the East

Corporation line of Wapakoneta (which is also the West right-of-way line of Rauthland Avenue extended North); thence East on the North right-of-way line of said Middle Street to the East right-of-way line of the platted alley in Rauthland Addition located on the East side of said addition; thence South on the East line of said alley to its intersection with the South right-of-way line of Bellefontaine Street; thence in a Northwesterly direction along the South right-of-way line of Bellefontaine Street to its intersection with the South right-of-way line of Fredericks Street to its intersection with the East right-of-way line of Rauthland Avenue located in the Second Rauthland Addition; thence North on the East right-of-way line of said Rauthland Avenue to an iron pin at its intersection with the South line of Bellefontaine Street; thence in a Northwesterly direction along the South right-of-way line of Bellefontaine Street to its intersection with the West right-of-way line of Rauthland Avenue of Rauthland Addition extended South; thence North along the West right-of-way line of Rauthland Avenue to its intersection with the North right-of-way line of Middle Street at the place of beginning.

Section 2. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
