Restrictions

1- Said premises shall be used solely and exclusively for single family private residence purposes. No residence or place of abode shall be erected, constructed, placed or suffered to remain upon said premises; A- which shall cost less than \$2500.00; B- nor within 100' of the center of the highway fronting on the south; C- nor 10' of either the east or the west line of said premises; D- nor sold or granted to any person not of the Caucasian race; E- nor shall the owner in any way interfere with the drainage rights of other owners of tracts adjacent to or near said property; F- nor shall any business, directly or indirectly be conducted on said premises; G- nor shall any nuisance be placed or suffered to remain on said premises, including outdoor toilets, the grantess herein agreeing to use a septic tank or proper sewer for drainage. Lots 17-18-19-20 excepted from these conditions.

2- No fence or wall of any kind shall be erected, placed or suffered to remain upon said premises nearer to any highway now existing than 150' <sup>unless</sup> said fence or hedge be of the ornamental type, and not more than 4' in height.

3- Failure of grantor, her heirs or assigns to enforce any of the restrictions or limitations, or covenants above set forth shall in no event be construed to be a waiver <sup>(a consent to future or succeeding breach)</sup> thereof or violation of same.
