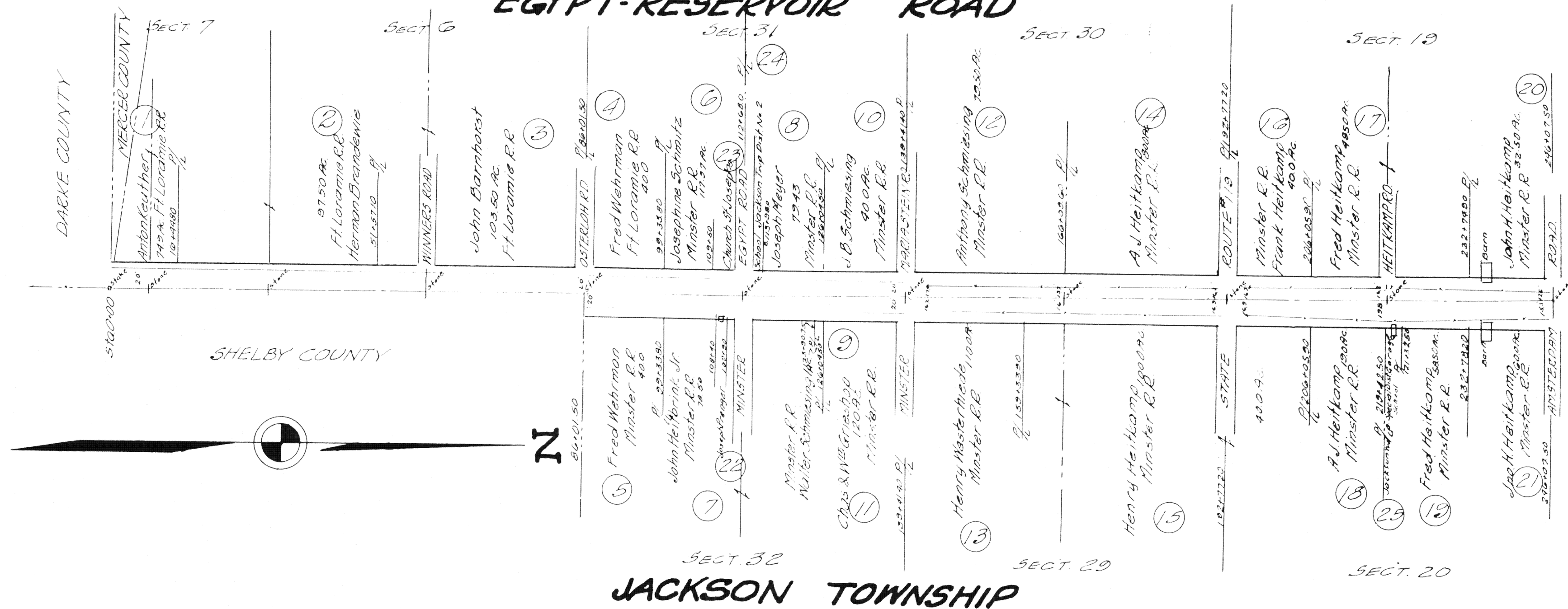


DEDICATION PLAT EGYPT-RESERVOIR ROAD



DESCRIPTION OF LAND DEDICATED

Beginning at a point on the east section line of Sec. 7, T-8-S, R-4-E, Jackson Township, Auglaize County, O. where said section line intersects the south county line of Auglaize County, thence running westerly 30 ft. to a point on the west right of way line, thence northerly along and parallel with the east Sect. line of Sects 7 & 6 T-8-S, R-4-E & Sects. 31, 30, & 19, T-7-S, R-4-E. To the North line of Jackson Township; thence easterly on north Township line 60 ft. to a Point. Thence southerly along & parallel to said North & South Section lines to a Point on South line of Sect. 32, T-7-S, R-4-E, thence westerly 30 ft. to S.W. Cor. of Sec. 32, thence southerly along East line of Sects. 6 & 7, T-8-S, R-4-E, to Point of beginning, of which present R/W occupies lands between fences & existing 40 ft R/W line as shown on plat above.

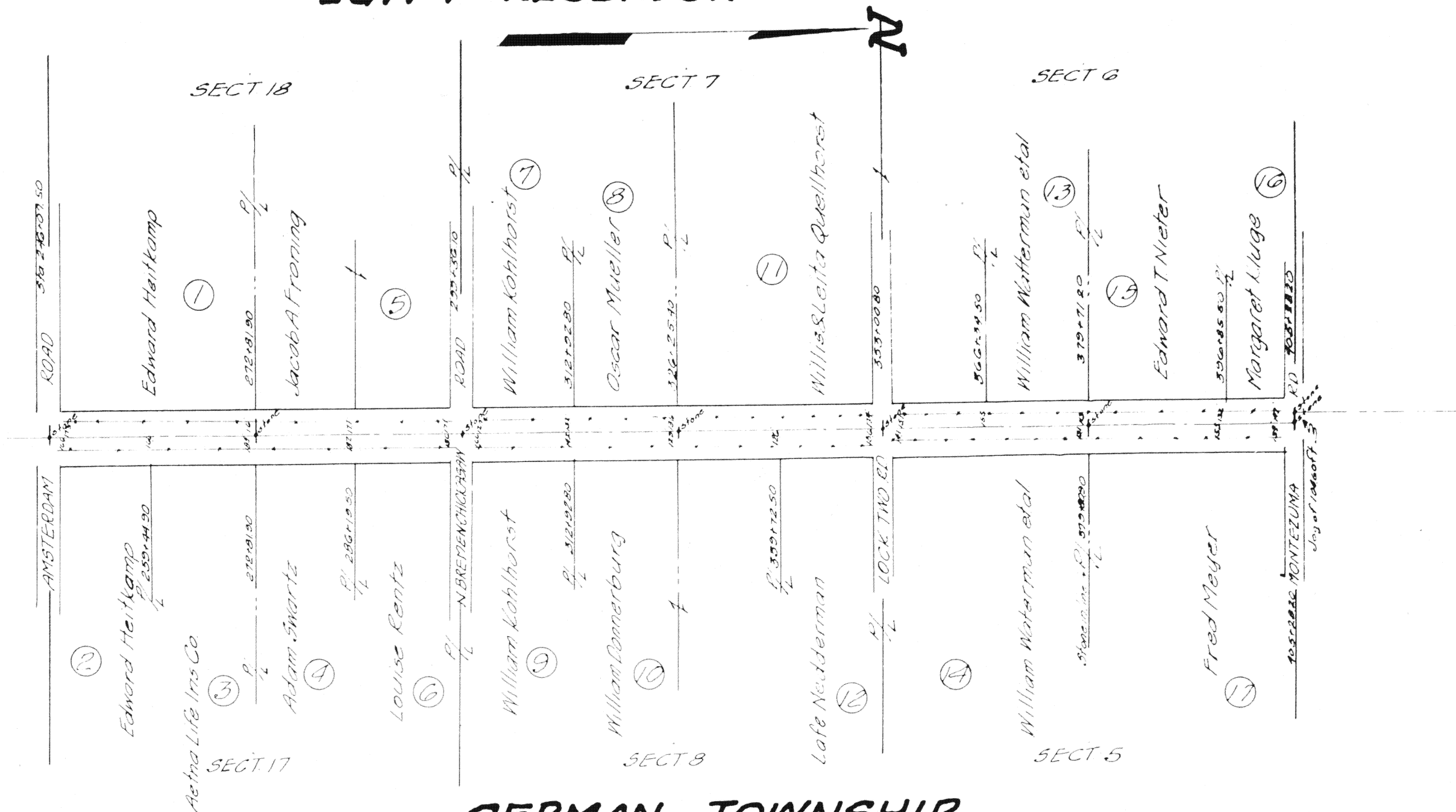

Description of Land Dedicated

Beginning at a stone at the south east corner of section 18, T. 7 S. - R. 4 E. German Twp. Auglaize Co. Ohio, thence running Westerly a distance of 30 ft. to a Point on the West Right of way Line; thence Northerly along & Parallel With East Sect. Line of Sects. 17, 7 & 6. T. 7 S. - R. 4 E. to a Point on South of the North Line of German Twp. T. 7 S. - R. 4 E.; thence Westerly Parallel With North Twp. Line 74.6 ft. to a Point, thence Northly Parallel With Said East Sect. Line 30 ft. to the North Line of German Twp. T. 7 S. - R. 4 E.; thence easterly Along Twp. Line 134.6 ft. to a Point in the east Right of Way Line; thence Southerly Along & Parallel to Said East Line of Sects. 6-7 & 18. 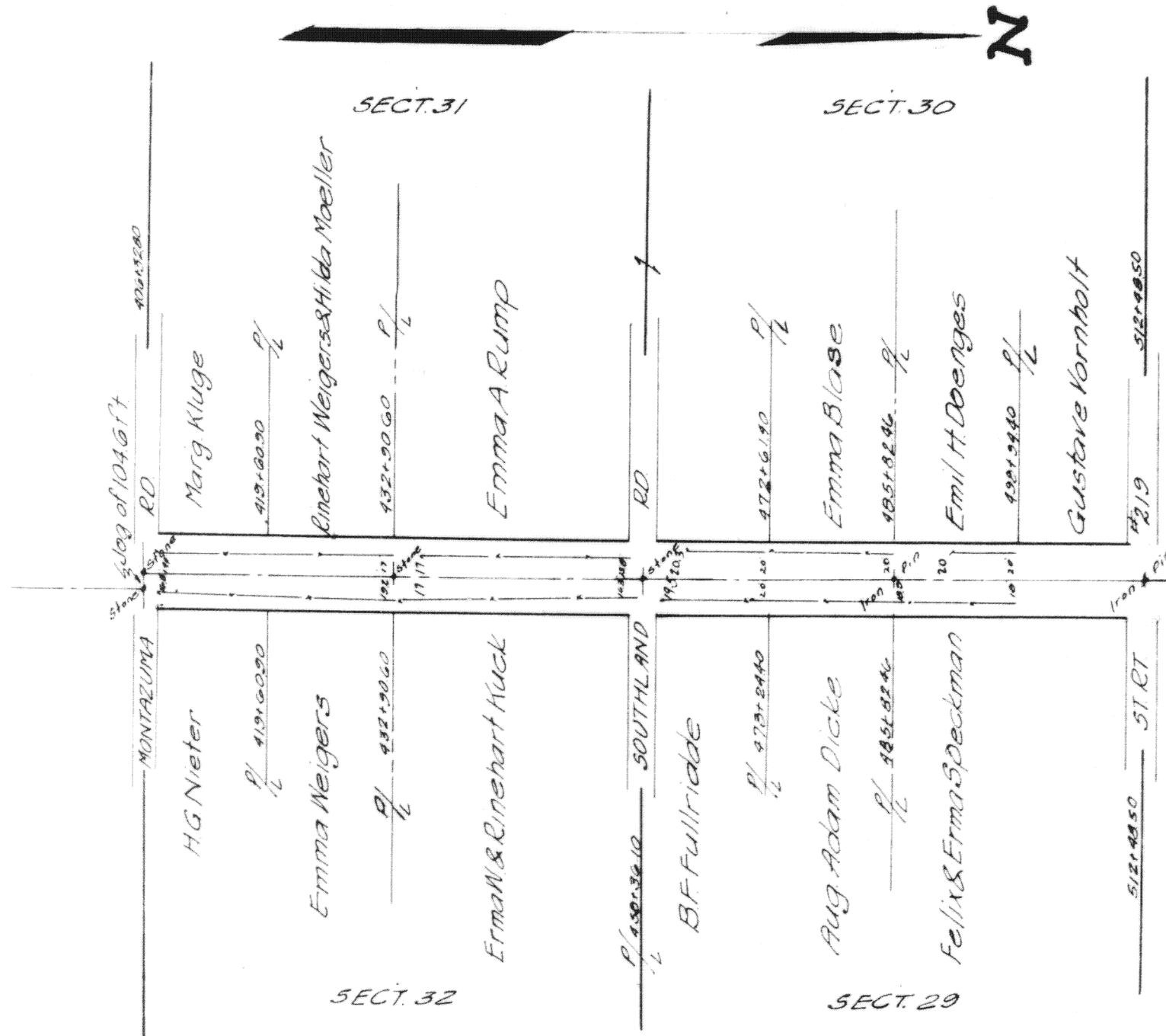
