Auglaize County Ohio; thence in a Northeasterly direction to a Point in the North Right-of-Way Line, Said Point being 25 ft North of the South Sect Line of Said Sect 19; thence easterly 25 ft distance from and Parallel with South Sect Line of Said Section 19, and South Sect Line of Section 20 T-6 S- R-6 E, Pusheta Township Auglaize County Ohio, to a Point; this Point being in the Inner Line of St. Rt. 25; thence in a Southeasterly direction Along Center Line of the Dixie Highway or State Route No 25 to a Point in the South Right of Way Line, Said Point being 25 feet South of the North Section Line of Section 27 T-6 S- R-6 E Auglaize County Ohio; thence Westerly 25 ft distance from and Parallel with the North Section Lines of Sections 29-30 T-6 S- R-6 E Pusheta Township, Auglaize County Ohio, to a Point, this Point being Also on the Center Line of the Hardin Pike; thence in a northeasterly direction to the Point of beginning

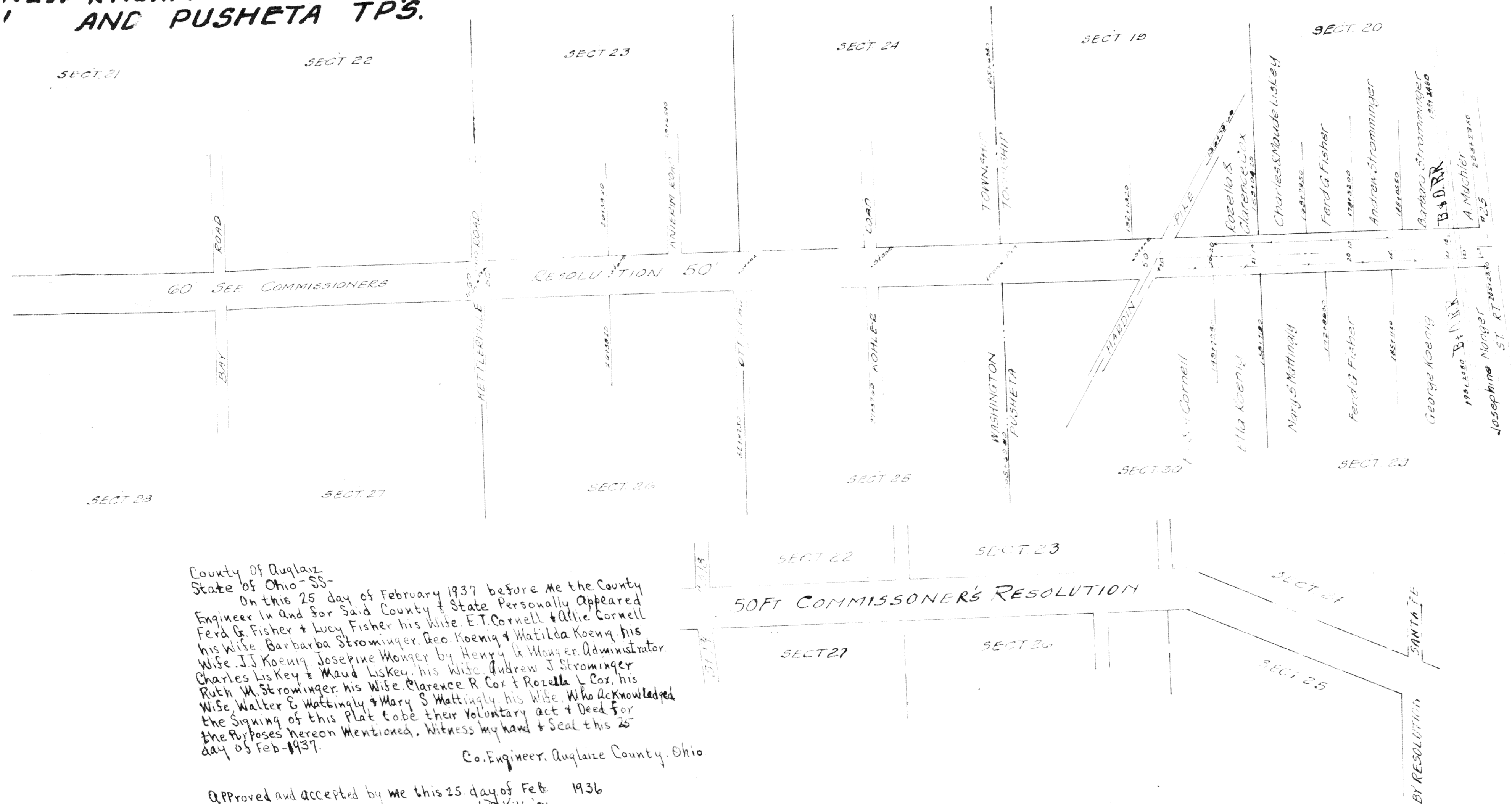
