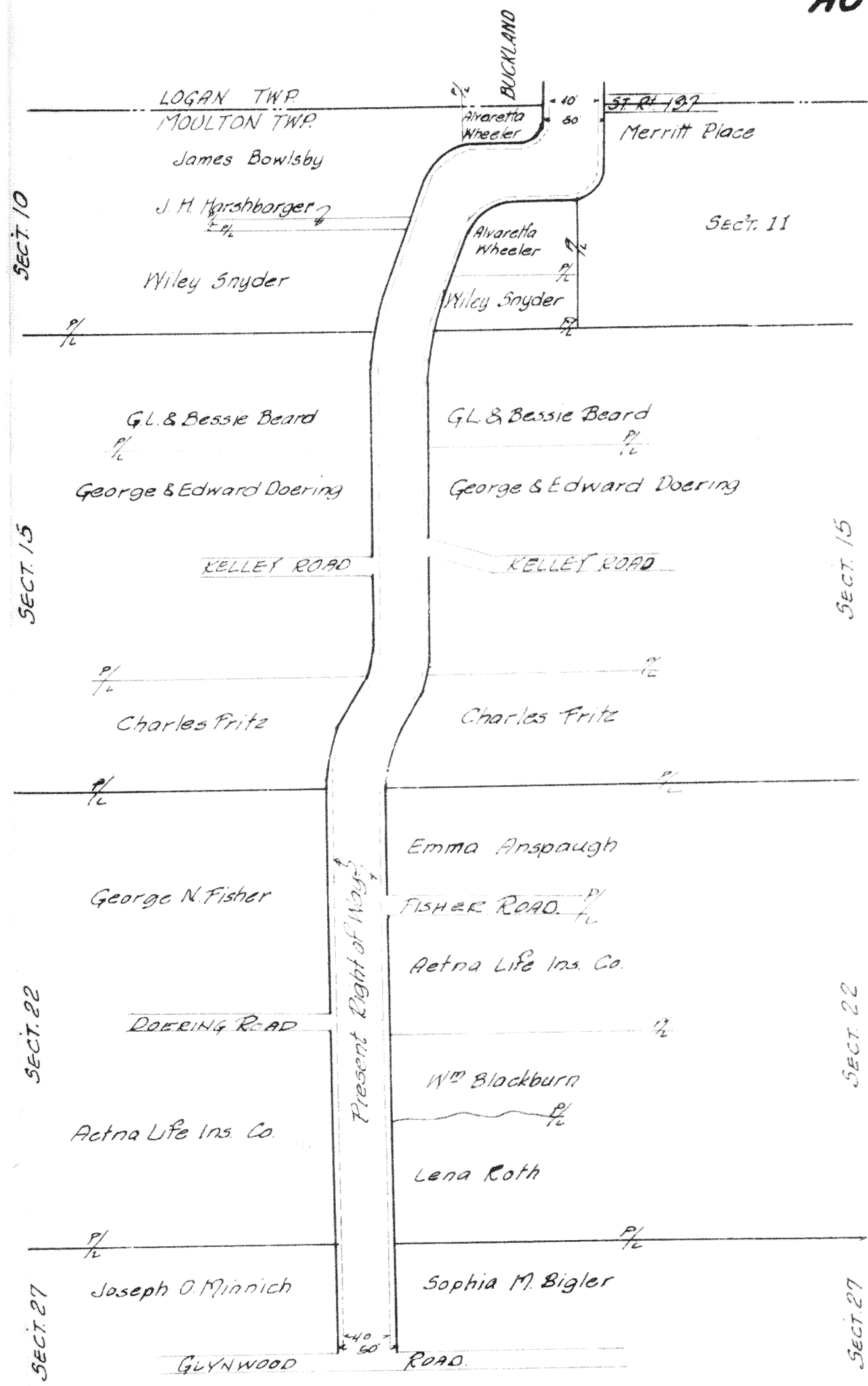


DEDICATION PLAT

DESCRIPTION: Commencing at the intersection of the centerline of the Main Street of Buckland and centerline of State Route 197 or the North East Corner of the South East Quarter of Sect 10, T5S.-R5E., Moulton Twp., Auglaize Co., Ohio; thence South along the centerline of the present Main St. Road. through Sects. 10, 15, 22 part of 27 & 11 all T5S.-R5E. to the Glynwood Road, and there terminate. The Right of Way on this Road to be widened to 60 ft., 25 ft each way from the above described centerline.

We, the undersigned, owners of the above described Property, dedicate the same to Public use for Road and other Public Purposes consistant therewith clear of all obstructions which interfere with the Improvement and/or Maintenance of the Highway.
