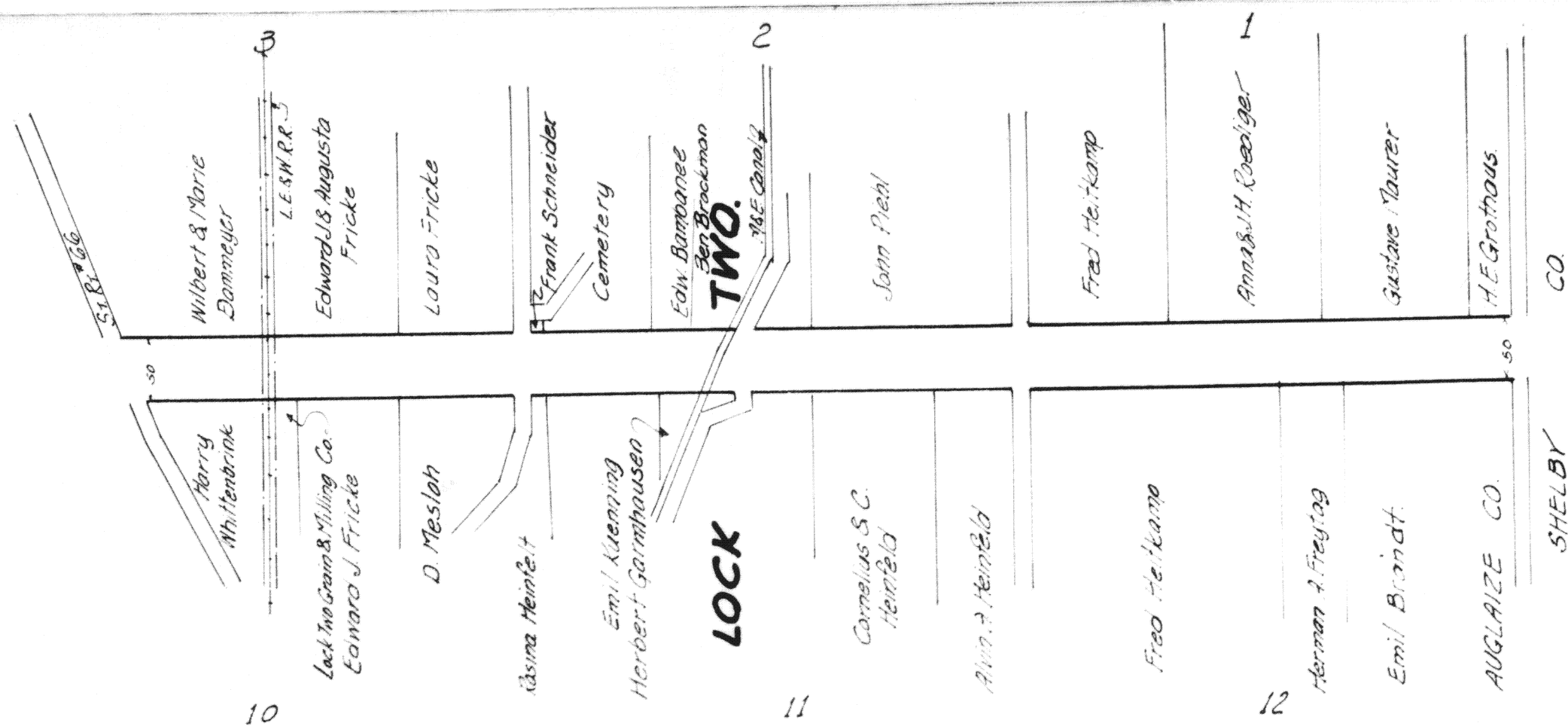




LOCK-TWO ROAD

DESCRIPTION: Beginning at the intersection of the South Section line and the centerline of State Highway #66 near the Southwest corner Southeast Quarter, Southwest Quarter of Section 3, T.7S. R.4E. German Township, Auglaize Co. Ohio; thence East along the Section lines between Sections 3 & 10, 2 & 11 and 1 & 12 all of above Town and Range, to the Shelby Auglaize County line and there terminate. The above described line to be the centerline of proposed improvement, and the Right of Way to be 25 feet each way from and parcel to the said centerline. Lock Two excluded.

We the undersigned, owners of the above described property, dedicate the same to public use for road and other purposes consistent therewith, clear of all obstructions which the Engineer may deprecate as such at time of improvement.
