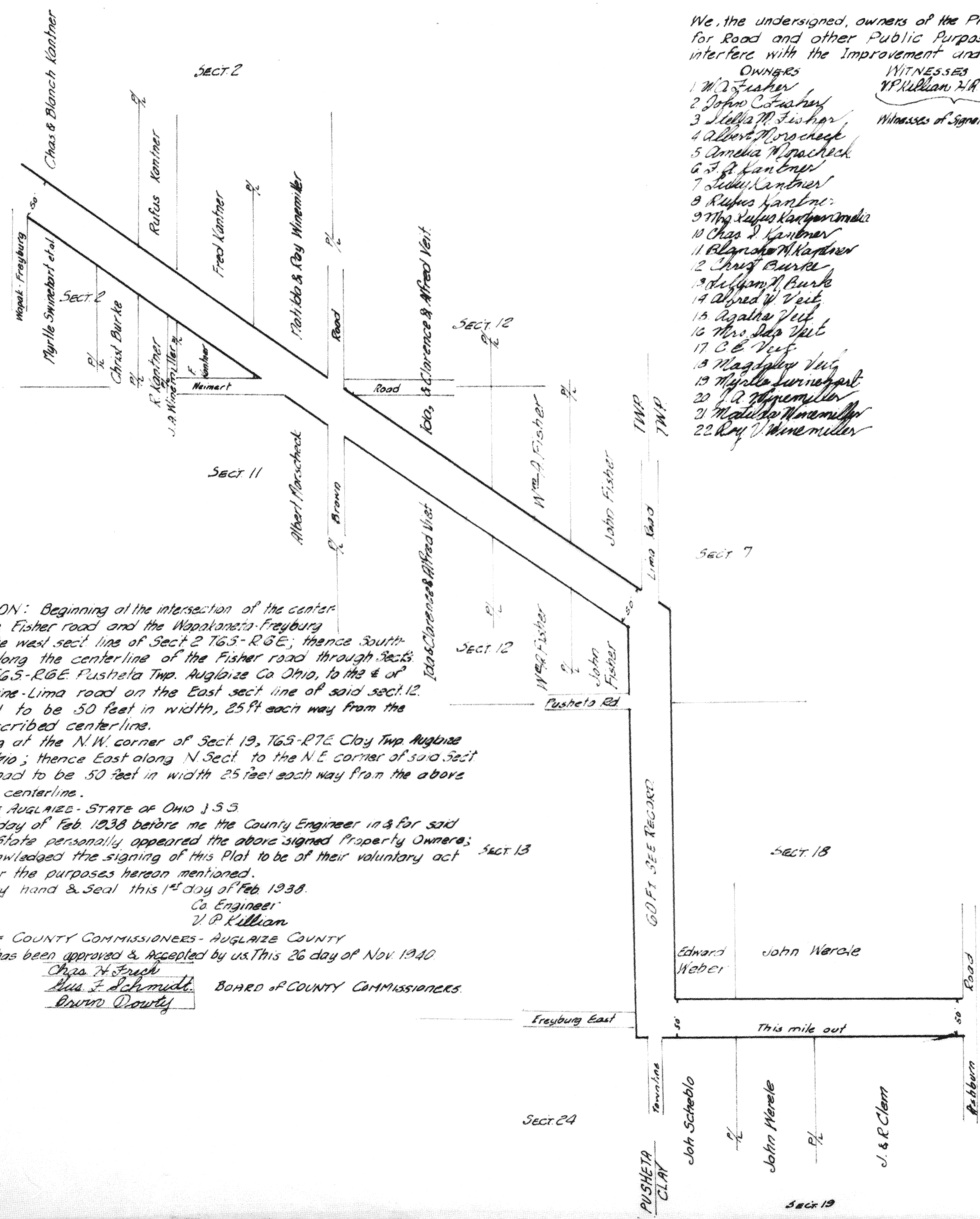

DESCRIPTION: Beginning at the intersection of the center lines of the Fisher road and the Wapakoneta-Freyburg road, on the west sec. line of Sect 2 T6S-R6E; thence South easterly along the centerline of the Fisher road through Sects. 2, 11 & 12 T6S-R6E. Pusheta Twp. Auglaize Co Ohio, to the E of the Townline-Lima road on the East sec. line of said sect. 12. This road to be 50 feet in width, 25 ft each way from the above described centerline.
Beginning at the N.W. corner of Sect 19, T6S-R7E Clay Twp. Auglaize County, Ohio; thence East along N. Sect. to the N.E. corner of said Sect 12. This road to be 50 feet in width 25 feet each way from the above described centerline.
