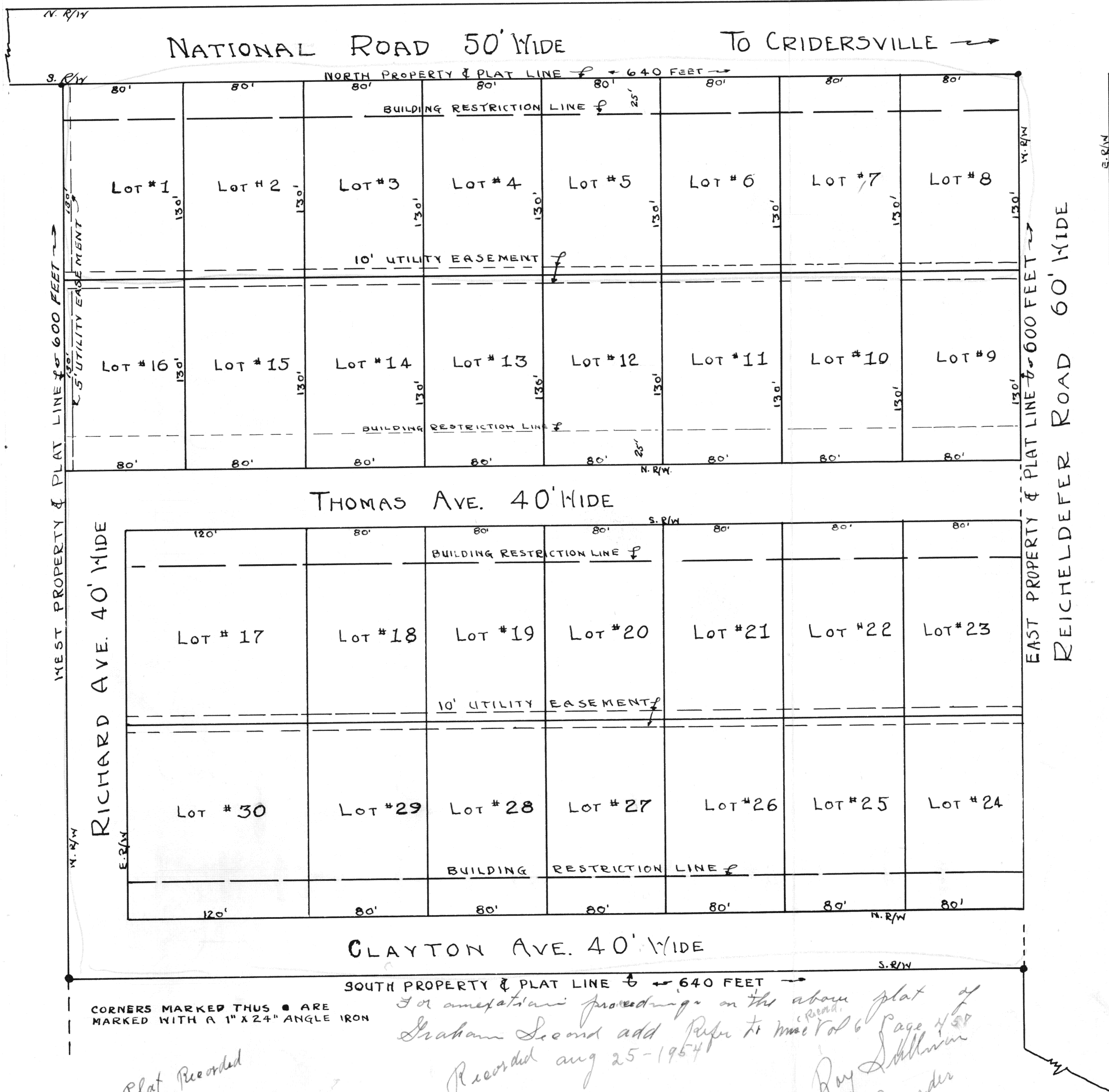


PLAT OF GRAHAM'S SECOND ADDITION TO CRIDERSVILLE

ORDINANCE NO. 1033

ACCEPTING APPLICATION FOR ANNEXATION OF TERRITORY.
BE IT ORDAINED, by the Council of the Village of Cridersville, State of Ohio:

SEC 1. That the Application of R.G. Graham and others for annexation of the following described territory in the County of Auglaize and adjacent to the Village of Cridersville, Auglaize County, Ohio, to-wit: Situate in the northeast quarter of Section 34, Town 4 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio, described as follows: Beginning on the south line of the National Road 640 feet east of the west line of said quarter; thence south parallel to said west line 135 feet to a point; thence east parallel to the National Road 640 feet to the west line of the Reichelderfer Road; thence north along said west line 135 feet to the south line of the National Road; thence west along said Road to the place of beginning.

Said above described real estate being known as a part of Graham's Second Addition to the Village of Cridersville, and further known as Lots 1 to 8 inclusive, and 5 feet off of the north end of Lots 9 to 16 inclusive.

An accurate map of which territory, together with the Petition for its annexation, and other papers relating thereto, and a certified transcript of the proceedings of the County Commissioners in relation thereto, are on file with the Clerk of said Village, be, and the same is hereby accepted.

SEC 2. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
