
# GUTHRIE SECOND ADDITION TO WAYNESFIELD, OHIO.



# ENGINEER'S CERTIFICATE

I hereby certify that the plat hereon represents correctly "Guthrie Second Addition to Waynesfield, Ohio", in Auglaize County, Ohio, laid out on the following described lands:

Beginning at a point in the North line of the Southeast quarter of the Southeast quarter of Section 18, Township 5 South, Range 8 East, the said point being four hundred twenty-one (421.00) feet West of the West line of Westminster Street; thence South parallel with the said West line of Westminster Street a distance of two hundred ninety (290.00) feet; thence West parallel with the North line of the quarter-quarter section a distance of three hundred twenty (320.00) feet; thence North parallel with the West line of the street a distance of two hundred ninety (290.00) feet to a point in the said North line of the quarter-quarter section; thence East a distance of three hundred twenty (320.00) feet to the place of beginning, 2.13 acres of land, more or less.

Stakes have been set at all lot corners. This survey was made under my direction and completed on the 23d day of June, 1953.

# RESTRICTIVE COVENANTS

- 1. No basement, trailer, tent, shack, or other outbuilding shall at any time be used as a residence.
- 2. All lets in this plat shall be known as residential lets. No structure other than a enefamily dwelling with garage, the sembined cost of which shall not be less than \$8500.00, shall be placed on a let.
  - 3. There shall be a cesspeel or septic tank for each residence.
- 4. If the parties herete, their heirs, administrators, or assigns, shall violate or attempt to violate any of the covenants herein, it shall be lawful for any person ewning any of the hereon lets or portion thereof to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such covenant or covenants to prevent him or them from doing so, or to recever damages or other dues for such violations.
  - 5. No nexious or offensive trade shall be carried on upon any of the lets shown on this plat.
- 6. Invalidation of any one of these covenants by judhement or court order shall in ne wise effect any of the other previsions which shall remain in full force and effect.
