- 1. All lots in this tract shall be known as residential lots. No structure shall be erected or placed on any lot other than one single family dwelling and one private garage not larger than two car and the combined cost not to be less than \$8500.00.
- 2. No building shall be erected or placed closer to the road than shown on the Plat.
- 3. No Noxious or offensive trade to be carried on upon any lot shown on the Plat.
- 4. No. trailer, basement, shack, tent or other out building shall at any time be used as a residence.
- 5. All septic tanks or cess pools shall be built to state specifications.
- 6. No building shall be placed closer than six feet to the sproperty
- 7. These covenants are to run with the land and shall be binding on all parties claiming under them until January 2, 1964 at which time they shall be automatically extended for successive periods of ten years unless by vote of majority of the then owners of the lots it is agreed to change the said covenants in whole or in part.

8. The above restrictions do not prohibit the erection of one poultry house, per lot, not larger than 12 x 14 ft.
