

ORDINANCE NO. 2279

AN ORDINANCE VACATING SHEETS STREET

WHEREAS, a petition was filed with the City of St. Marys by the interested property owners, praying therein that Sheets Street be vacated and notice of the vacation having been waived since all property owners abutting upon the proposed vacation had joined in and signed said petition; and,

WHEREAS. Council is satisfied that for good cause the vacation should be made.

NOW THEREFORE, BE IT ORDAINED, BY THE COUNCIL, FOR THE CITY OF ST. MARYS, OHIO:

SECTION 1. That Sheets Street from William Street to Edwards Street, be and is hereby vacated, save and excepting for the intersection of the alley and Sheets Street, SUBSTEET TO AFULL WIDTH UTILITY FASEMENT ON THE VACATED STREAT.

SECTION 2. That this ordinance shall be in force and take effect at the earliest possible date provided by law.
