SURVEYOR'S CERTIFICATE

I HEREBY CERTIFY THAT I SURVEYED IN JUNE, 1957, THE FOLLOWING DESCRIBED TRACT OF LAND IN THE SOUTHWEST 1/4 OF SECTION II, T75-R4E IN GERMAN TOWNSHIP, AUGLAIZE COUNTY, OHIO, AND THAT HARDWOOD STAKES WERE PLACED AT ALL LOT CORNERS.

BEGINNING AT A POINT IN THE CENTERLINE OF STATE HIGHWAY #274, THIS BEING TAKEN TO BE THE SOUTH LINE OF SECTION II, THIS POINT BEING AT THE CENTERLINE OF A BRIDGE, 132' EAST OF THE CORPORATION LINE OF THE VILLAGE OF NEW BREMEN; THENCE EAST ON THE SOUTH LINE OF SECTION II FOR A DISTANCE OF 535.1', THENCE NORTH PARALLEL TO THE CORPORATION LINE OF THE VILLAGE OF NEW BREMEN FOR A DISTANCE OF 947.30'; THENCE WEST PARALLEL TO THE SOUTH LINE OF THE SECTION FOR A DISTANCE OF 657.1' MORE OR LESS TO THE CENTERLINE OF A STREAM, THIS CENTERLINE BEING 10' MORE OR LESS EAST OF THE CORPORATION LINE OF THE VILLAGE OF NEW BREMEN; THENCE SOUTH ON THIS CENTERLINE OF THE STREAM FOR A DISTANCE OF 191.30'; THENCE WEST TO THE CORPORATION LINE FOR A DISTANCE OF 10' MORE OR LESS; THENCE SOUTH ON THE CORPORATION LINE FOR A DISTANCE OF 156' TO THE CENTERLINE OF STATE HIGHWAY #274; THENCE EAST ON THIS HIGHWAY FOR A DISTANCE OF 132' TO THE PLACE OF BEGINNING.
