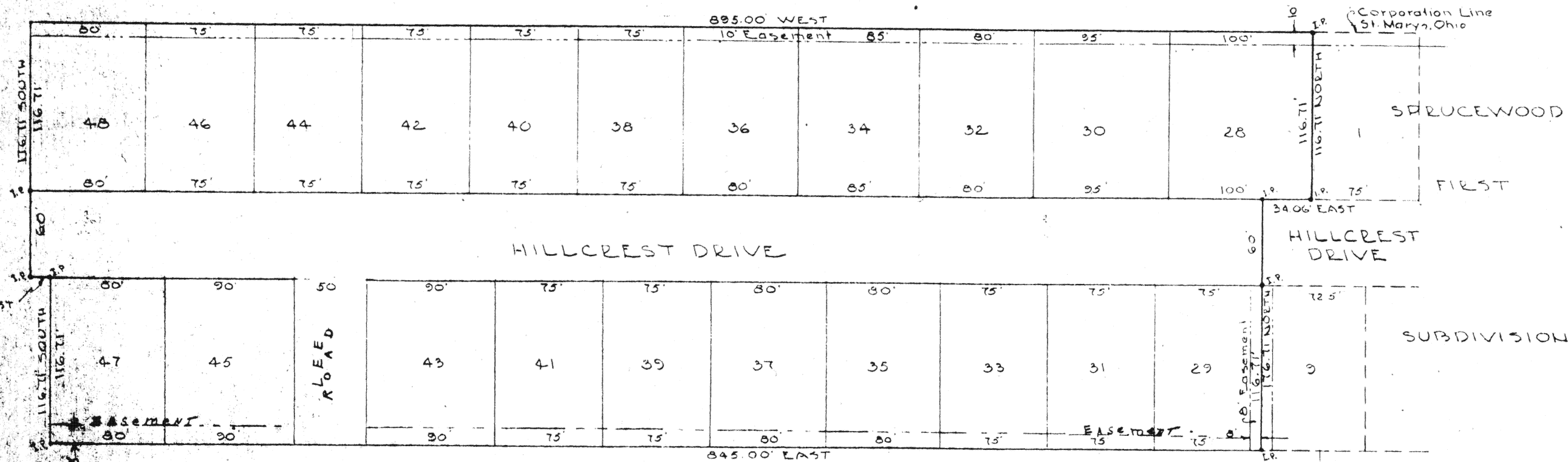


# SPRUCEWOOD SECOND ADDITION ST. MARYS, OHIO

AN ORDINANCE TO CHANGE THE NAME OF LEE ROAD  
LOCATED IN THE SPRUCEWOOD SUBDIVISION IN ST.  
MARYS, OHIO, TO MEADOW LANE.

WHEREAS, on the 27<sup>th</sup> day of MARCH, 1967, a petition  
by persons owning lots in the immediate vicinity of the present named "Lee  
Road" was duly presented to Council praying that said street be renamed and  
hereafter be known as "Meadow Lane, and,

WHEREAS, Council, upon hearing, is satisfied that there is good cause  
for such change of name as prayed for, that said change will not be detri-  
mental to the general interest and ought to be made.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
ST. MARYS, OHIO:

SECTION 1. That the street presently named "Lee Road" is hereby  
renamed and will be known henceforth as "Meadow Lane".

SECTION 2. That this ordinance be and remain in force from and after  
the earliest period allowed by law.
