

**Dedication:**



Engineer's Certificate

The following tract of land is part of the NE 1/4 of the NE 1/4 of Section 22, Duchouquet Township, T55 RGE, with reference to the First Principal Meridian, Auglaize County, Ohio, and is more particularly described as follows:

Beginning at the center of a concrete corner post of the northeast corner of section 22 thence due West a distance of 804.65 feet to an iron pipe; thence S0°18'W a distance of 529.50 feet to a concrete monument which is the Place of Beginning; thence continuing S0°18'W thru a concrete monument @ 197.20 feet and to a P-K nail in the centerline of SR 67 at 230.00 feet; thence S66°30'W along the centerline of SR 67 a distance of 571.40 feet to a P-K nail; thence N0°18'E (thru a concrete monument at 32.80 feet) a total distance of 230.00 feet to a concrete monument; thence N66°30'E a distance 571.40 feet to the concrete monument which was the Place of Beginning. The above tract contains 2.76 acres subject to 0.39 acre dedicated for highway purposes.

Restrictions:

A dwelling constructed on any lot in this subdivision shall contain not less than 1000 sq.ft. on the first floor if it is a one story structure; not less than 800 sq.ft. on the first floor if it is a two story structure and not less than 900 sq.ft. on the first floor if it is a story and a half structure.

All rules and regulations of Duchouquet Township zoning and planning commission shall be adhered to.

Terms and requirements of County Health Board:

All sewage disposal devices shall conform to the Auglaize County sanitary regulations and shall consist of a sewage tank and a leaching device. The size of the secondary treatment shall be based upon the percolation tests as defined on the preliminary plot in the office of the Auglaize County Health Commissioner. Sewage disposal devices shall be installed in the front of each property. All water supplies shall be developed at the rear of each property and shall conform to state standards regarding location, construction and development.
