## DESCRIPTION

BEING A PART OF FRACTION #1 IN THE N.W. 1/4 OF SECTION 35, IN THE VILLAGE OF CRIDERSVILLE, DUCHOUQUET TOWNSHIP, AUGLAIZE COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:  
BEGINNING AT A POINT IN THE NORTH LINE OF SECTION 35 AND THE NORTH CORPORATION LINE OF THE VILLAGE OF CRIDERSVILLE, THIS POINT BEING 371.00 FEET EAST OF THE NORTHWEST CORNER OF SECTION 35; THENCE EAST ALONG THE NORTH LINE OF SECTION 35 AND THE CORPORATION LINE FOR A DISTANCE OF 40.00 FEET; THENCE SOUTH PARALLEL TO THE EAST LINE OF FRACTION #1 FOR A DISTANCE OF 377 FEET PLUS OR MINUS TO THE NORTH LINE OF NORTH STREET; THENCE WEST ALONG THE NORTH LINE OF NORTH STREET FOR A DISTANCE OF 40.00 FEET; THENCE NORTH PARALLEL TO THE EAST LINE OF FRACTION #1 FOR A DISTANCE OF 377 FEET PLUS OR MINUS TO THE NORTH LINE OF SECTION 35 AND THE PLACE OF BEGINNING.
