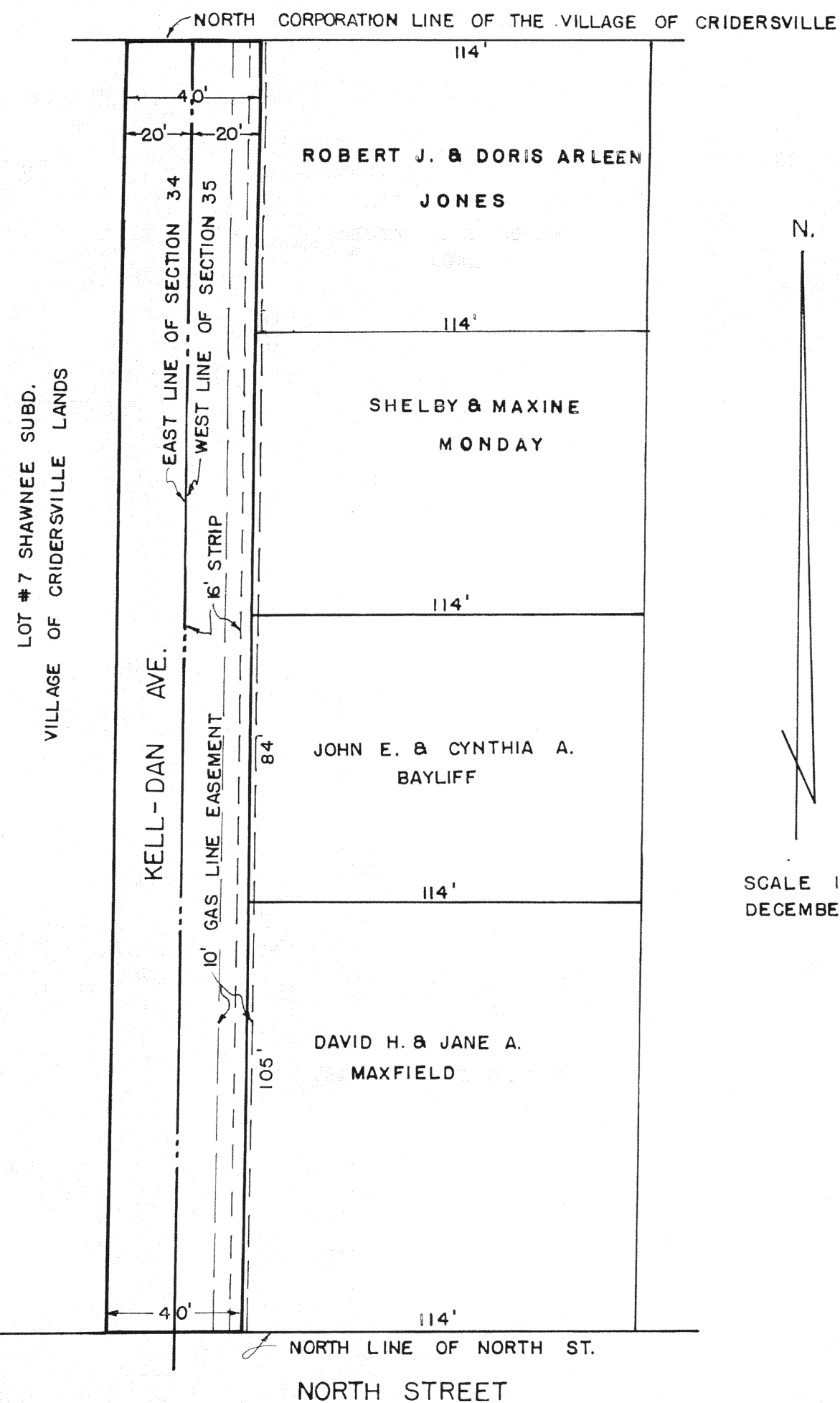


KELL - DAN AVE. DEDICATION PLAT

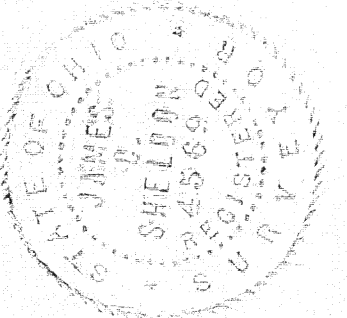
DESCRIPTION

BEING A TRACT IN THE N.E. 1/4 OF SECTION 34 & THE N.W. 1/4 OF SECTION 35, IN THE VILLAGE OF CRIDERSVILLE, DUGHOQUET TOWNSHIP, AUGLAIZE COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT THE INTERSECTION OF THE WEST LINE OF SECTION 35 & THE NORTH CORPORATION LINE OF THE VILLAGE OF CRIDERSVILLE; THENCE EAST ALONG SAID NORTH CORPORATION LINE FOR 20 FEET; THENCE SOUTH, PARALLEL THE WEST LINE OF SECTION 35, TO THE NORTH LINE OF NORTH STREET; THENCE WEST ALONG THE NORTH LINE OF NORTH STREET, A DISTANCE OF 40.00 FEET; THENCE NORTH PARALLEL THE EAST LINE OF SECTION 34, TO THE NORTH CORPORATION LINE OF THE VILLAGE OF CRIDERSVILLE; THENCE EAST ALONG THE SAID CORPORATION LINE FOR A DISTANCE OF 20.00 FEET TO THE PLACE OF BEGINNING.
