

# Engineer-Surveyor's Certificate

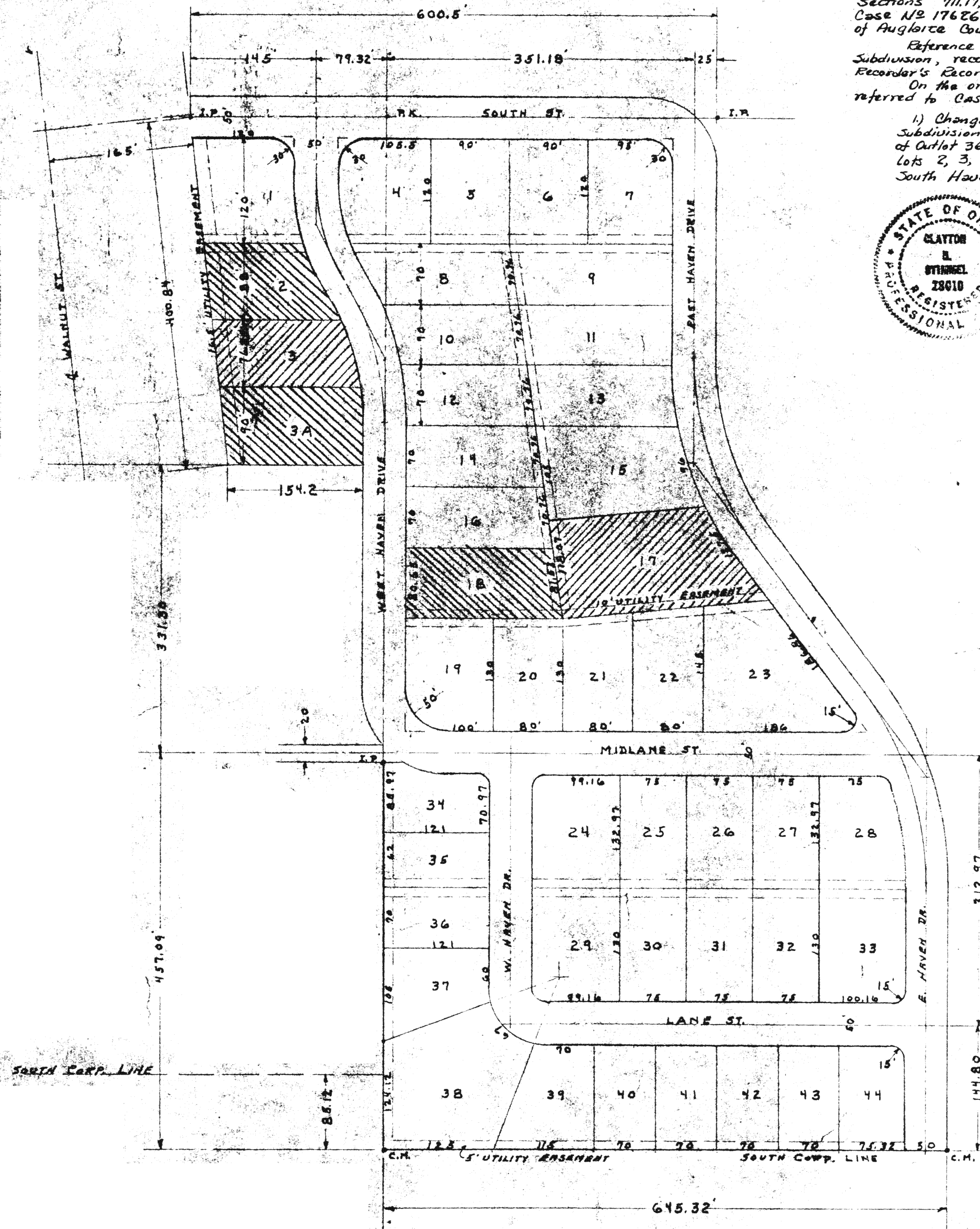
