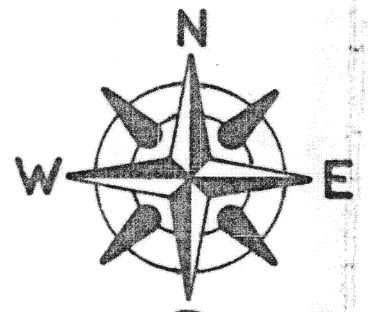


ANNEXATION TO MINSTER - OHIO

Being 15.075 Acres located in the North-West quarter of Section 26, Town - 7S, Range - 4E, Jackson Township, Auglaize County, Ohio and being further described as follows: Commencing at a monument box at the North-West corner of Section 26. Thence South 0° 12' East with the center of State Route # 66 and the West line of Section 26, a distance of 1549.65 feet to the PLACE OF BEGINNING for the tract of land herein described, Thence continuing South 0° 12' East with said center line and section line, a distance of 664.39 feet to a point. Thence North 88° 47' East, a distance of 990.28 feet to a concrete monument. (passing through a concrete monument at 55.00 feet from center line at the R/W line) Thence North 0° 16' West, a distance of 662.45 feet to a concrete monument. Thence South 88° 54' West, a distance of 989.48 feet to a point in the center of State Route # 66 and the West line of Section 26, (passing through a concrete monument 50.00 feet east from center line at the R/W line) and the PLACE OF BEGINNING. Containing in all 15.075 Acres and being subject to all legal easements and R/W of record. (Bearings oriented to match State of Ohio R/W Plans)
