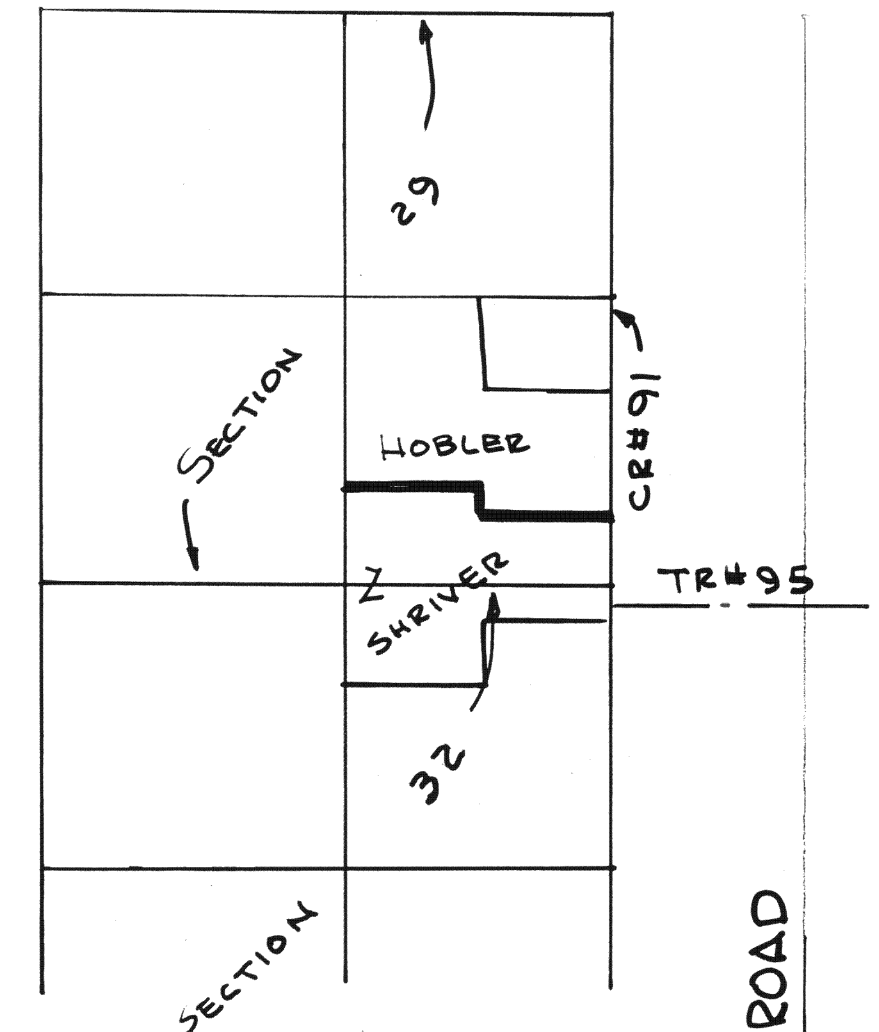


PROPERTY LINE AGREEMENT PLAT

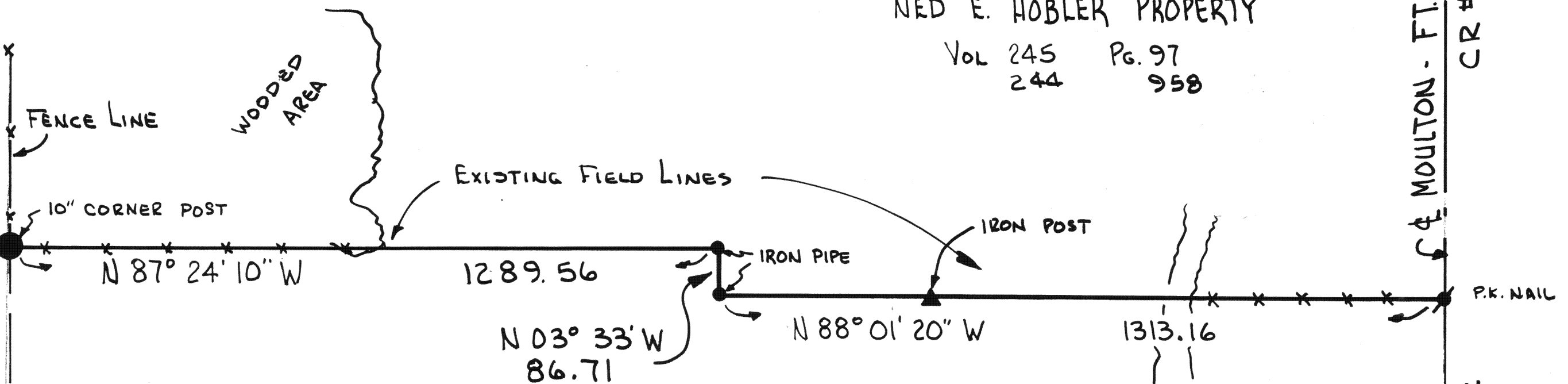
