



REGULA BOUNDARY LINE AGREEMENT


- IRON PIN SET

NOTES:

THE SOUTH EAST CORNER OF THE NORTH EAST QUARTER OF SECTION 25, PUSHETA TOWNSHIP, WAS ESTABLISHED BY MEASURING THE TOTAL NORTH-SOUTH DISTANCE AND PROTRACTING IT TO THE DISTANCE AS FOUND IN THE 1893 SURVEY BY SAMUEL CRAIG LOCATED IN BOOK 3, PAGE 6 IN THE AUGLAIZE COUNTY ENGINEER'S OFFICE.

THE BOUNDARY LINE AS AGREED UPON BY THE PARTIES HERIN CONCERNED IS ALONG A STRAIGHT LINE BETWEEN THE IRON PIN 5.1' SOUTH OF THE SE CORNER OF THE NORTHEAST QUARTER OF SECTION 25 AND THE WOODEN END POST AS OCCUPIED AT THE CENTER OF SECTION 25. SAID NEW BOUNDARY LINE RUNS WESTERLY FROM THE IRON PIN 5.1' SOUTH OF THE SE CORNER OF THE NORTHEAST QUARTER OF SECTION 25 TO THE SOUTHWEST CORNER OF A 40 ACRE TRACT OF LAND AS DESCRIBED IN DEED BOOK 262, PAGE 23, IN THE AUGLAIZE COUNTY RECORDER'S OFFICE.


C.R. 100 - SANTA FE - NEW KNOXVILLE ROAD
