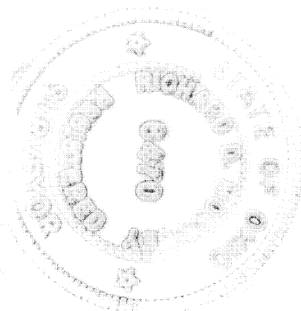


RIGHT-OF-WAY DEDICATION Pt. E 1/2, NE 1/4 SECTION 30, T-5-S, R-6-E, DUCHOUQUET TOWNSHIP, CITY OF WAPAKONETA, AUGLAIZE COUNTY, OHIO.

DESCRIPTION

Being a parcel of land situate in the east half of the Northeast quarter of Section 30, T-5-S, R-6-E, Duchouquet Township lying within the Corporation Limits of the City of Wapakoneta, Auglaize County, Ohio and more particularly described as follows:

Commencing at the intersection of the north line of said Northeast quarter of said Section 30 with the centerline of State Route 198; thence southeasterly with said centerline of said State Route 198, 1,110.00 feet to a point; thence northeasterly perpendicular to said centerline of said State Route 198, 30.00 feet to a point on the east right-of-way line of said State Route 198 and the PLACE OF BEGINNING; thence continuing northeasterly perpendicular to said centerline, 30.00 feet to a point; thence southeasterly parallel to said centerline of said State Route 198, 60.00 feet to a point; thence southwesterly perpendicular to said centerline, 30.00 feet to a point on the east right-of-way line of said State Route 198; thence northwesterly with said east right-of-way line, 60.00 feet to the PLACE OF BEGINNING containing 1,800.000 square feet or 0.041 acre more or less and subject to all legal easements of record.

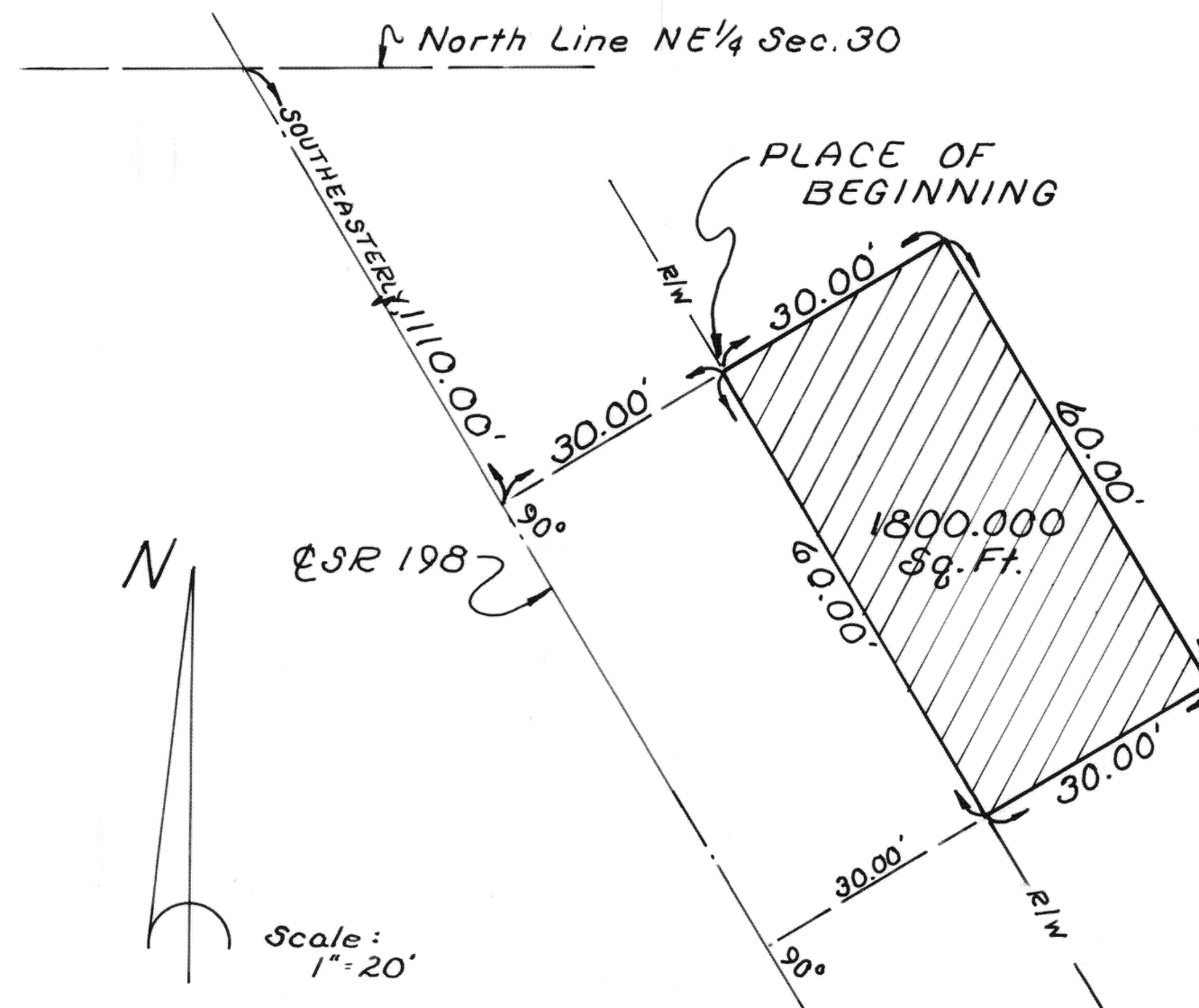
