
REPLAT OF TRACT "E"

WEST OAKS MEADOWS Nº5

PT. OF SECTION 4, T-6-S, R-4-E, CITY OF ST. MARYS, ST. MARYS TOWNSHIP, AUGLAIZE COUNTY, OHIO



DESCRIPTION

Being a parcel of land situate in the northwest quarter of Section 4, T-6-S, R-4-E, St. Marys Township, Auglaize County, Ohio, and being more particularly described as follows:

Beginning at a found concrete monument at the northwest corner of Lot 469 in West Oaks Meadows No. 4, said monument also being on the west line of Section 4, St. Marys Township; thence N 00°36'29"W, 297.92 feet with said west line of Section 4, to a found iron pipe at the southwest corner of Lot 481 in West Oaks Meadows No. 5; thence N 89°00'00"E, 277.96 feet with the south line of Lots 481, 480, & 479 in said West Oaks Meadows No. 5 to a found iron pipe at the southeast corner of said Lot 479; thence S 01°00'00"E, 297.91 feet with the west line of Tracts "F" and "D" in West Oaks Meadows passing through found iron pipes at 139.26 feet and 189.26 feet on the north and south right-of-way lines of Winston Drive to a found concrete monument at the southwest corner of said Tract "D"; thence S 89°00'00"W, 280.00 feet with the north line of West Oaks Meadows No. 4 to the PLACE OF BEGINNING.
