


PLAT OF DEDICATION FOR PARCEL N^o 1

NW 1/4 SECTION 33, T-5-S, R-6-E, DUCHOUQUET TWP, AUGLAIZE COUNTY,
CITY OF WAPAKONETA,

LEGAL DESCRIPTION

Being a strip of land 50' in width situate in the northwest quarter of Section 33, T-5-S, R-6-E, Duchouquet Township, Auglaize County, Ohio, more particularly described as follows:

Commencing at a P.K. nail at the northwest corner of the northwest quarter, Section 33;
thence N 89°08'04" W with the north line of said northwest quarter (centerline of Middle Pike Road, C-150), 656.86 feet to the PLACE OF BEGINNING;
thence S 01°52'02" W, 2161.61 feet to the centerline of Bellefontaine Street;
thence N 56°22'00" W with said centerline 58.81 feet to a railroad spike;
thence N 01°52'02" E, 2129.78 feet to the north line of said northwest quarter (centerline of Middle Street);
thence S 89°08'04" E with said north line 50.01 feet to the PLACE OF BEGINNING, containing 2.463 acres more or less.
