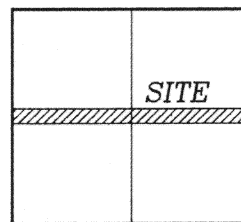


LOCATION PLAN

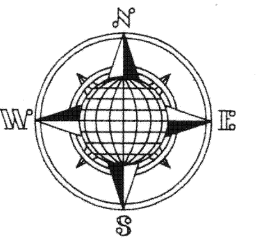

DESCRIPTION:

The following described tract of land is part of Section 31, Town 7 South, Range 4 East, Jackson Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at a R.R. Spike found at the Southeast corner of the Northeast Quarter of Section 31, Jackson Township also being the intersection of the centerlines of County Road 26 (Minster-Egypt Pike) and State Route 364.
thence N.88°44'33"W. along the South line of the Northeast Quarter of said Section 31 and the centerline of County Road 31 to the Monument Box at the Southwest corner of the Northeast Quarter of Section 31, Jackson Township;
thence N.88°44'28"W. along the South line of the Northwest Quarter of Section 31 and the centerline of County Road 26 to the Monument Box at the Southwest corner of the Northwest Quarter of Section 31, Jackson Township, and there to terminate.

This road is to be 50 feet in width, (except for all parcels owned by the Archbishop of Cincinnati), 25 feet each way from the above described centerline, of which 16.5 feet each way from the above described centerline has already been dedicated.

We, the undersigned owners, dedicate the same to public use for Road and other public purposes consistent therewith clear of all obstructions which interfere with the improvements and / or Maintenance of the Highway.
