In part of the southwest quarter of Section 10 is a tract of land (1 Acre more or less) owned by the St. Johns Lutheran Church. The boundary lines of the church property, as appears at the site contain 1 acre of land more or less. The configuration of the property as it exists does not reflect the intent of the initial boundaries. As told by the current owner of the land adjacent north of the church (Mr. Kaeck), a trade off of land had occurred at least twice over the past 80 to 100 years. With all parties in agreement, the 1.103 Acres contained within the bounds of the existing church & cemetery property represents the intended ownership today. 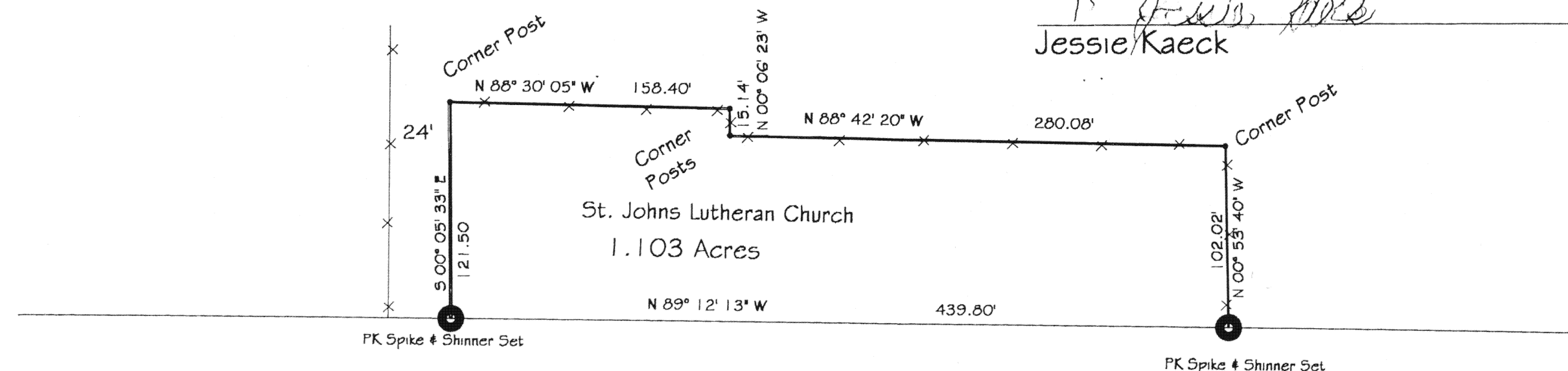
