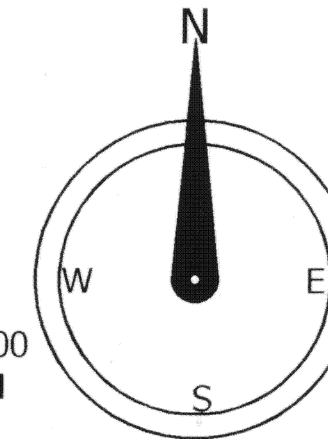


DEDICATION OF PUBLIC RIGHT OF WAY

State plane Co-ord System

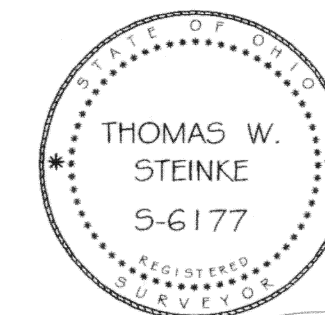
