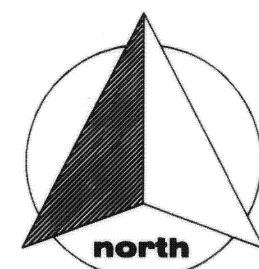

GRAPHIC SCALE



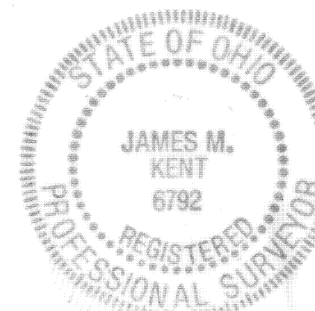
