PART OF THE N.W. 1/4 OF SECTION 17, T-5-S, R-8-E, WAYNE TOWNSHIP, AUGLAIZE COUNTY, OHIO

SURVEYOR'S DESCRIPTION

Being a part of the northwest quarter of Section 17, T-5-S, R-8-E, Wayne Township, Village of Waynesfield, Auglaize County, Ohio and more particularly described as follows:

Commencing at a p-k nail (found) at the northwest corner of said Section 17 and the legal centerline intersection of SR 196 and Fairmount Road; thence, S 00 degrees 17' 57" E along the legal centerline of SR 196 and the west line of the northwest quarter of Section 17, for a distance of 377.73 feet to a railroad spike (found) and the POINT OF BEGINNING for the tract herein described;

thence, N 89 degrees 49' 38" E (passing through an iron pin found on the easterly right-of-way line of SR 196 at a distance of 30.00 feet) for a total distance of 650.27 feet to an iron pin (found);

thence, N 00 degrees 19' 38" W for a distance of 377.33 feet to the north line of the northwest quarter of Section 17 and the legal centerline of Fairmount Road and a p-k nail (found);

thence, N 89 degrees 49' 38" E along the aforesaid north line and legal centerline, for a distance of 61.89 feet to a railroad spike (found);

thence, S 00 degrees 15' 41" E for a distance of 217.80 feet to a 5/8" re-rod (found);

thence, N 89 degrees 49' 38" E for a distance of 600.10 feet to a 5/8" re-rod (found);

thence, S 00 degrees 15' 41" E for a distance of 1585.91 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 21' 29" W for a distance of 530.00 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 15' 41" E for a distance of 27.07 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 21' 29" W for a distance of 129.89 feet to a 5/8" re-rod w/cap (set);

thence, N 00 degrees 19' 38" W for a distance of 1259.78 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 49' 38" W (passing through a 5/8" re-rod w/cap set on the east right-of-way line of SR 196 at a distance of 629.36 feet) for a total distance of 659.36 feet to a cotton gin spindle (set) on the west line of the northwest quarter of Section 17 and the legal centerline of SR 196;

thence, N 00 degrees 17' 57" W along the aforesaid legal centerline and west line, for a distance of 199.08 feet to the POINT OF BEGINNING, containing therein 27.503 acres, of which 0.172 acres is existing road right-of-way.
