

LAKELAND SUBDIVISION

Replat of Lots 561, 562-563, and 564.

SURVEYOR'S DESCRIPTION:

Being Lots 561, 562-563, and 564 of Lakeland Subdivision of a part of the NW 1/4 of Section 30, T-5-S, R-6-E, Duchouguet Township (part of the Duchouget Reserve), City of Wapakoneta, Auglaize County, Ohio as evidenced by OR Volume 609, Page 481, OR 562, Page 563 and OR 512, Page 2244 and more particularly described as follows:

BEGINNING at a 5/8" re-rod w/cap (found) at the northeast corner of Lot 565 and the south right-of-way line of Camation Drive; thence, along a tangent curve to the left, said curve having a central angle which measures 05° 01' 06", a radius which measures 1029.25 feet, a chord which bears N 87° 03' 07" E and a chord which measures 90.12 feet, for a total arc length of 90.15 feet to a 5/8" re-rod w/cap (found) at a point of reverse curve;

thence, along the aforesaid south right-of-way line on a tangent curve to the right, said curve having a central angle which measures 04° 33' 33", a radius which measures 972.85 feet, a chord which bears N 86° 49' 20" E and a chord which measures 77.39 feet, for a total arc length of 77.41 feet to a 5/8" re-rod w/cap (set):

thence, the aforesaid south right-of-way line on a tangent curve to the right, said curve having a central angle which measures 11° 24' 21", a radius which measures 972.85 feet, a chord bears S 85°11'43'E, a chord which measures 193.34 feet, for a total arc length of 193.66 feet to a 5/8" re-rod w/cap (found) at the northwest corner of Lot 560;

thence, S 11° 08' 44" W along the west line of said Lot 560 for a distance of 146.30 feet to a 5/8" re-rod w/cap (found) at the south west corner of Lot 560:

thence, N 75° 51' 52" W along the south line of Lakeland Subdivision for a distance of 109.84 feet to a 5/8" re-rod w/cap (found):

thence, continuing along the aforesaid south line S 83° 58' 34"W (passing through a 5/8" re-rod w/cap set at a distance of 56.00 feet) for a total distance of 154.71 feet to a 5/8" re-rod w/cap (found) at a point of curve:

thence, along a tangent curve to the right, said curve having a central angle which measures 04° 13' 16", a radius which measures 954.93 feet, a chord which bears S 86° 05' 12" W, a chord which measures 70.34 feet, for a total arc length of 70.35 feet to a 5/8" re-rod w/cap (found) at the southeast corner of Lot 565:

thence, N 00° 26' 20" W along the east line of Lot 565 for a distance of 145.03 feet to the POINT OF BEGINNING, containing therein 1.120 acres.

DEDICATION:

We the undersigned owners do hereby dedicate this re-plat, and all the easements shown to the City of Wapakoneta for their exclusive use. It is understood that the original plat covenants and restrictions will continue to apply to the re-platted lots.
