



LEGAL DESCRIPTION

BEING LOT 95 AND LOT 96, BLOCK D AND SITUATED IN THE SOUTHWEST QUARTER OF SECTION 26, TOWN 7 SOUTH, RANGE 4 EAST, JACKSON TOWNSHIP, VILLAGE OF MINSTER, AUGLAIZE COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

COMMENCING AT AN IRON PIN SET AT THE SOUTHEAST CORNER OF LOT 96, BLOCK D AND THE INTERSECTION OF THE WEST RIGHT-OF-WAY LINE OF JEFFERSON STREET AND THE NORTH RIGHT-OF-WAY LINE OF EAST FIFTH STREET, SAID POINT BEING THE TRUE POINT OF BEGINNING;

THENCE NORTH 89°29'12" WEST ALONG NORTH RIGHT-OF-WAY LINE OF EAST FIFTH STREET, A DISTANCE OF TWO HUNDRED NINETEEN AND FORTY-SEVEN HUNDREDTHS FEET (219.47') TO A POINT AT THE SOUTHWEST CORNER OF LOT 96, BLOCK D AND THE EAST LINE OF A 16' ALLEY, WITNESS AN IRON PIN FOUND AT SOUTH 28°03'18" EAST, 0.36 FEET;

THENCE NORTH 01°24'01" EAST ALONG THE EAST LINE OF A 16' ALLEY, A DISTANCE OF ONE HUNDRED THIRTY-SIX AND FIFTY-TWO HUNDREDTHS FEET (136.52') TO AN IRON PIN SET AT THE NORTHWEST CORNER OF LOT 95, BLOCK D;

THENCE SOUTH 89°29'12" EAST ALONG NORTH LINE OF LOT 95, BLOCK D, A DISTANCE OF TWO HUNDRED NINETEEN AND TWENTY-TWO HUNDREDTHS FEET (219.22') TO AN IRON PIN SET AT THE NORTHEAST CORNER OF LOT 95, BLOCK D AND THE WEST RIGHT-OF-WAY OF JEFFERSON STREET;

THENCE SOUTH 01°17'38" WEST ALONG THE WEST RIGHT-OF-WAY OF JEFFERSON STREET, A DISTANCE OF ONE HUNDRED THIRTY-SIX AND FIFTY-ONE HUNDREDTHS FEET (136.51') TO THE TRUE POINT OF BEGINNING, CONTAINING 0.687 ACRES OF LAND MORE OR LESS.


