LOCATED IN THE SOUTHWEST QUARTER OF SECTION 26, TOWN 7 SOUTH, RANGE 4 EAST, JACKSON TOWNSHIP IN THE VILLAGE OF MINSTER, AUGLAIZE COUNTY, OHIO, AND BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING FOR REFERENCE AT A MONUMENT BOX FOUND AT THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF SECTION 26;

THENCE, NORTH 89°39'10" WEST, 1101.72 FEET, ALONG THE NORTH LINE OF SAID QUARTER SECTION AND THE NORTH RIGHT-OF-WAY LINE OF SEVENTH STREET TO A POINT:

THENCE, SOUTH 01°11'56" WEST, 933.25 FEET, TO AN IRON PIN SET AT THE INTERSECTION OF THE SOUTH RIGHT-OF-WAY LINE OF SIXTH STREET AND THE WEST RIGHT-OF-WAY LINE OF HAMILTON STREET, SAID POINT BEING THE TRUE POINT OF BEGINNING;

THENCE, SOUTH 01'11'56" WEST, 832.24 FEET, ALONG THE WEST RIGHT-OF-WAY LINE OF HAMILTON STREET TO AN IRON PIN SET AT THE INTERSECTION OF THE WEST RIGHT-OF-WAY LINE OF HAMILTON STREET AND THE NORTH RIGHT-OF-WAY LINE OF FIFTH STREET;

THENCE, NORTH 89°29'32" WEST, 456.75 FEET, ALONG THE NORTH RIGHT-OF-WAY LINE OF FIFTH STREET TO AN IRON PIN SET AT THE INTERSECTION OF THE NORTH RIGHT-OF-WAY LINE OF FIFTH STREET AND THE EAST RIGHT-OF-WAY LINE OF JEFFERSON STREET;

THENCE, NORTH 01°17'58" EAST, 831.17 FEET, ALONG THE EAST RIGHT-OF-WAY LINE OF JEFFERSON STREET TO AN IRON PIN SET AT THE INTERSECTION OF THE EAST RIGHT-OF-WAY LINE OF JEFFERSON STREET AND THE SOUTH RIGHT-OF-WAY LINE OF SIXTH STREET;

THENCE, SOUTH 89°37'45" EAST, 455.31 FEET, ALONG THE SOUTH RIGHT-OF-WAY LINE OF SIXTH STREET TO THE TRUE POINT OF BEGINNING;

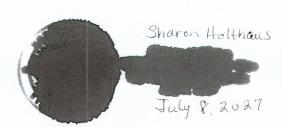
